

Closed surfaces and character varieties

The powerful character variety techniques of Culler and Shalen can be used to find essential surfaces in knot manifolds. We show that module structures on the coordinate ring of the character variety can be used to identify detected boundary slopes as well as when closed surfaces are detected. This approach also yields new number theoretic invariants for the character varieties of knot manifolds.

1 Introduction

Suppose that N is a compact, irreducible 3–manifold with torus boundary and that X is an irreducible algebraic component of the $\mathrm{SL}_2\mathbb{C}$ –character variety for N . It is known that the dimension of X is at least one Cooper, Culler, Gillet, Long and Shalen [6]. Often, interesting topological information about N may be obtained from the algebraic geometry of X .

Let $C \subseteq X$ be an affine algebraic curve and $\tilde{C} \rightarrow C$ a birational map from a smooth projective curve. This map is defined for all but finitely many points. These points are called ideal points. For $\gamma \in \pi_1 N$ and $\chi \in X$, define $I_\gamma(\chi) = \chi(\gamma)$. This determines a rational function $I_\gamma: \tilde{C} \rightarrow \mathbb{C}$. This paper concerns the following landmark result of Culler and Shalen.

Theorem 1.1 (Culler and Shalen) *If \hat{x} is an ideal point, there is an associated non-empty essential surface Σ in N .*

- (1) Σ may be chosen to have empty boundary if and only if I_α is regular at \hat{x} for every peripheral element $\alpha \in \pi_1 N$.
- (2) Otherwise, there exists a unique slope with the property that if $\alpha \in \pi_1 N$ represents this slope, then I_α is regular at \hat{x} . In this case, every component of $\partial\Sigma$ represents the slope corresponding to α .

When an essential surface arises from X and this theorem, we say that the surface is detected by X .

Since 1983, case (2) of Theorem 1.1 has been carefully studied. Many famous papers have provided both applications and insight for this case. Notably, the Culler–Shalen norm of Culler, Gordon, Luecke and Shalen [9] and the A –polynomial of [6] can tell us exactly which slopes are detected. These tools are remarkably effective and have been used in proofs of several famous theorems including the Smith Conjecture (Shalen [24]) and the Cyclic Surgery Theorem [9].

It is well-known that if $\dim(X) > 1$, then X detects a closed essential surface. Not much is known about case (1) of Theorem 1.1 when $\dim(X) = 1$. Also, it is difficult to interpret global properties of X in terms of the topology of N . This paper introduces new functions that relate detected boundary slopes and essential closed surfaces in the manifold to module structures of the coordinate ring $\mathbb{C}[X]$. In the spirit of Cooper and Long [7], these functions also contain number theoretic information about X .

The trace ring $T(X)$ is the subring (with unity) of the coordinate ring $\mathbb{C}[X]$ that is generated by $\{I_\gamma \mid \gamma \in \pi_1 N\}$. Define $T_{\mathbb{Q}}(X)$ to be the smallest \mathbb{Q} –algebra in $\mathbb{C}[X]$ that contains $T(X)$. Suppose that $\alpha \in \pi_1 N$ is primitive and peripheral. Then $\mathbb{C}[X]$, $T_{\mathbb{Q}}(X)$ and $T(X)$ have the structure of a $\mathbb{C}[I_\alpha]$ –module, a $\mathbb{Q}[I_\alpha]$ –module and a $\mathbb{Z}[I_\alpha]$ –module, respectively. Let $\text{Rk}_X^{\mathbb{C}}(\alpha)$, $\text{Rk}_X^{\mathbb{Q}}(\alpha)$ and $\text{Rk}_X^{\mathbb{Z}}(\alpha)$ denote the ranks of these modules. Note that the functions I_α are well-defined on slopes. Hence, these rank functions may be viewed as functions on \mathcal{S} , the set of slopes for N . It is clear that

$$(1) \quad \text{Rk}_X^{\mathbb{C}} \leq \text{Rk}_X^{\mathbb{Q}} \leq \text{Rk}_X^{\mathbb{Z}}.$$

The following theorem is the main theorem of this paper.

Theorem 1.2 *Let X be an irreducible component of $X(N)$ and $\mathbb{X} \in \{\mathbb{C}, \mathbb{Q}, \mathbb{Z}\}$. Then*

- (1) *The function $\text{Rk}_X^{\mathbb{X}}: \mathcal{S} \rightarrow \mathbb{Z}^+ \cup \{\infty\}$ is constant with value ∞ if and only if X detects a closed essential surface.*
- (2) *Otherwise, $\text{Rk}_X^{\mathbb{X}}(\alpha) = \infty$ if and only if X detects the slope α .*

We begin by proving the theorem for $\mathbb{X} = \mathbb{C}$. A straightforward application of this case yields a proposition of independent interest.

Proposition 1.3 *Let X° be the union of the irreducible components X' of the $SL_2\mathbb{C}$ –character variety such that*

- (1) *X' detects a closed essential surface if and only if X does, and*

- (2) for each slope α , X' detects a surface with boundary slope α if and only if X does.

Then X° is defined over \mathbb{Q} .

This proposition, together with Theorem 1.1, also allows us to improve the result to include $\mathbb{X} = \mathbb{Q}$. As an application of this result, we prove another proposition. It is of independent interest, but is also used to prove the main theorem in the case $\mathbb{X} = \mathbb{Z}$.

Proposition 1.4 *If X contains the character of a non-integral representation that detects a closed essential surface, then X detects a closed essential surface.*

Together with data compiled by Goodman, Heard and Hodgson, this proposition gives many examples of hyperbolic knot manifolds for which the hyperbolic components of their character varieties detect closed essential surfaces.

In addition to our main result, we begin an investigation of the basic properties of the functions $\text{Rk}_X^{\mathbb{X}}$ and include computations for several examples. It is easy to prove the following two propositions.

Proposition 1.5 *Suppose that N is a knot manifold and $H_1(N; \mathbb{Z}) \cong \mathbb{Z}$, generated by α . Let $X_A \subseteq X(N)$ be the curve consisting of all abelian representations of $\pi_1 N$. Then*

$$\text{Rk}_{X_A}^{\mathbb{C}}(\alpha) = \text{Rk}_{X_A}^{\mathbb{Z}}(\alpha) = 1.$$

Proposition 1.6 *If N is a knot manifold and X is a norm curve component of $X(N)$, then $\text{Rk}_X^{\mathbb{C}}(\alpha) \geq 2$ for every slope α .*

As a corollary to Theorem 1.2, we have the following.

Corollary 1.7 *Suppose N is the exterior of a two-bridge knot and $\langle \mu, \beta \mid \omega\beta = \mu\omega \rangle$ is the standard presentation for $\pi_1 N$. If $X \subset X(N)$ is an irreducible algebraic component defined over \mathbb{Q} , then X is defined by an irreducible polynomial of the form*

$$I_{\mu\beta}^n - \sum_{j=0}^{n-1} p_j(I_\mu) I_{\mu\beta}^j.$$

The set $\{I_{\mu\beta}^j\}_0^{n-1}$ is a free basis for $\mathbb{C}[X]$ as a $\mathbb{C}[I_\mu]$ -module, $T_{\mathbb{Q}}(X)$ as a $\mathbb{Q}[I_\mu]$ -module and $T(X)$ as a $\mathbb{Z}[I_\mu]$ -module.

We point out that, with the appropriate definitions, these results also hold for the $\mathrm{PSL}_2\mathbb{C}$ -character variety. In what follows, we use X to indicate that we are working in the $\mathrm{SL}_2\mathbb{C}$ setting and Y in the $\mathrm{PSL}_2\mathbb{C}$ setting. When $N \subset S^3$ is a knot exterior, we reserve $\lambda, \mu \in \pi_1 N$ to be a longitude, meridian pair. We write X_A and Y_A for the algebraic sets of abelian characters. When N is hyperbolic, we use the notation X_0 and Y_0 to indicate algebraic components of the character varieties that contain a discrete faithful character.

Below, we list the results of our calculations in five different examples. The last example is of particular interest. It shows that the inequalities (1) need not be equalities and that, although $T(X)$ must always be torsion free as a $\mathbb{Z}[I_\sigma]$ -module, it need not be a free module.

- (1) Suppose N is the exterior of a trefoil knot. Then $X(N) = X_A \cup X$, where X_A is a curve of abelian characters and X is a curve that contains an irreducible character. We have

$$\mathrm{Rk}_X^{\mathbb{Z}}(\mu) = 1.$$

This shows that the converse to Proposition 1.5 does not hold.

- (2) Suppose N is the exterior of the figure-eight knot. We have

$$\begin{aligned} \mathrm{Rk}_{X_0}^{\mathbb{Z}}(\mu) &= \mathrm{Rk}_{Y_0}^{\mathbb{Z}}(\mu) = 2, \\ \mathrm{Rk}_{Y_0}^{\mathbb{C}}(\lambda) &= \mathrm{Rk}_{Y_0}^{\mathbb{Z}}(\lambda) = 4, \\ \mathrm{Rk}_{Y_0}^{\mathbb{C}}(\mu^2\lambda) &= \mathrm{Rk}_{Y_0}^{\mathbb{Z}}(\mu^2\lambda) = 5. \end{aligned}$$

- (3) Suppose $N = M_{003}$. Then $\pi_1 N = \langle \gamma, \eta \mid \gamma\eta\gamma^{-2}\eta\gamma\eta^3 \rangle$. Define $\mu = (\eta^2\gamma\eta\gamma)^{-1}$ and $\lambda = (\gamma\eta\gamma)^{-1}\eta\gamma\eta$. Then μ and λ are primitive, peripheral and generate a peripheral subgroup of N . We have

$$\mathrm{Rk}_{X_0}^{\mathbb{C}}(\mu) = \mathrm{Rk}_{X_0}^{\mathbb{Z}}(\mu) = 4.$$

Also, $I_\mu \in T(Y_0)$ and

$$\mathrm{Rk}_{Y_0}^{\mathbb{C}}(\mu) = \mathrm{Rk}_{Y_0}^{\mathbb{Z}}(\mu) = 2.$$

Note that, since Y_0 is a norm curve, these ranks achieve their minimum possible value. In contrast to examples (1) and (2), the $\mathrm{PSL}_2\mathbb{C}$ -rank is strictly smaller than the $\mathrm{SL}_2\mathbb{C}$ -rank (at μ). As with examples (1) and (2), all of these $\mathbb{Z}[I_\mu]$ -modules are free.

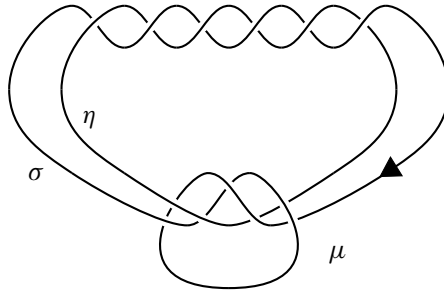


Figure 1: The knot 8_{20} labelled with Wirtinger generators

- (4) Suppose N is the exterior of the knot 8_{20} . N is hyperbolic, so we consider X_0 . The diagram in Figure 1 gives a Wirtinger presentation for $\pi_1 N$, which reduces to $\langle \mu, \gamma \mid \mu\gamma(\mu\gamma\mu)^{-1}\gamma^3(\mu\gamma\mu)^{-1}\gamma\mu\gamma^{-2} \rangle$, where $\gamma = \eta\sigma$.

The functions I_μ , I_γ and $I_{\gamma\mu}$ give an embedding of X_0 into \mathbb{C}^3 . I_γ and $I_{\gamma\mu}$ both satisfy irreducible integral dependencies in $\mathbb{Z}[I_\mu][x]$ of degree 5. It follows that $\mathcal{B} = \{I_\gamma^i I_{\gamma\mu}^j \mid 0 \leq i, j \leq 4\}$ is a generating set for $\mathbb{C}[X_0]$ as a $\mathbb{C}[I_\mu]$ -module, $T_{\mathbb{Q}}(X_0)$ as a $\mathbb{Q}[I_\mu]$ -module and $T(X_0)$ as a $\mathbb{Z}[I_\mu]$ -module. Notice that $|\mathcal{B}| = 25$.

A Groebner basis argument shows that relations amongst the elements of \mathcal{B} are plentiful and, in fact, $\{1, I_\gamma, I_\gamma^2, I_\gamma^3, I_\gamma^2 I_{\gamma\mu}, I_{\gamma\mu}\}$ is a free basis for each of the above modules. Hence,

$$\text{Rk}_{X_0}^{\mathbb{C}}(\mu) = \text{Rk}_{X_0}^{\mathbb{Z}}(\mu) = 6$$

and $T(X_0)$ is a free $\mathbb{Z}[I_\mu]$ -module.

- (5) Suppose N is the once punctured hyperbolic torus bundle from Section 5 of Dunfield [11]. Then $\pi_1 N = \langle \alpha, \beta, \tau \mid \tau\alpha\tau^{-1} = (\beta\alpha\beta)^{-1}, \tau\beta\tau^{-1} = \beta\alpha(\beta\alpha\beta)^{-3} \rangle$. The elements τ and $\lambda = [\alpha, \beta]$ form a basis for the peripheral subgroup of N and the functions

$$t = I_\tau, \quad u = I_{\alpha\tau}, \quad v = I_{\beta\tau}, \quad w = I_{\alpha\beta\tau}, \quad x = I_\alpha, \quad y = I_\beta, \quad z = I_{\alpha\beta}$$

give an embedding of $X(N)$ into \mathbb{C}^7 . For $\epsilon \in \{0, 1\}$, we have an irreducible algebraic component $X_\epsilon \subset X(N)$ that contains a discrete faithful character.

- (a) $\{1, z, z^2, z^3, y, zy, z^2y, z^3y\}$ is a free basis for $\mathbb{C}[X_\epsilon]$ as a $\mathbb{C}[I_\lambda]$ -module. Hence, $\text{Rk}_{X_\epsilon}^{\mathbb{C}}(\lambda) = 8$.
- (b) $\{1, z, z^2, z^3, y, zy, z^2y, z^3y, t, zt, z^2t, z^3t, yt, zyt, z^2yt, z^3yt\}$ is a free basis for $T(X_\epsilon)$ as a $\mathbb{Q}[I_\lambda]$ -module. Hence, $\text{Rk}_{X_\epsilon}^{\mathbb{Q}}(\lambda) = 16$.
- (c) $\{1, y, y^2, y^3, t, u, v, w, x, z, yt, yu, yx, y^2x, xt, xu, vy\}$ generates $T(X_\epsilon)$ as a $\mathbb{Z}[I_\lambda]$ -module. However, $T(X_\epsilon)$ is torsion free but *not* free as a $\mathbb{Z}[I_\lambda]$ -module. In particular, $\text{Rk}_{X_\epsilon}^{\mathbb{Z}}(\lambda) = 17$.

The projection $(t, y, z): X_0 \cup X_1 \rightarrow \mathbb{C}^3$ is an isomorphism onto its image and the relation

$$\text{Rk}_{X_\epsilon}^{\mathbb{Q}}(\lambda) < \text{Rk}_{X_\epsilon}^{\mathbb{Z}}(\lambda)$$

reflects the fact that the inverse of this isomorphism is not defined over \mathbb{Z} . The equality

$$\text{Rk}_{X_\epsilon}^{\mathbb{Q}}(\lambda) = 2 \cdot \text{Rk}_{X_\epsilon}^{\mathbb{C}}(\lambda)$$

reflects the fact that X_ϵ is not defined over \mathbb{Q} .

2 Algebraic geometry

Throughout this section we take k to be an algebraically closed field. All varieties are defined over k . When X is an irreducible variety we write $k[X]$ and $k(X)$ to denote the ring of regular functions on X and the function field for X , respectively. If $p \in X$, define $\mathcal{O}_{X,p}$ to be the ring of germs of functions that are regular on neighborhoods of p . We have a surjective homomorphism $k[X] \rightarrow k$ given by $f \mapsto f(p)$. Let \mathfrak{m}_p be the maximal ideal that is the kernel of this map. By Theorem 3.2 part (c) of Hartshorne [14], $\mathcal{O}_{X,p}$ is isomorphic to the localization $k[X]_{\mathfrak{m}_p}$. We use this isomorphism to identify these two rings and think of $\mathcal{O}_{X,p}$ as a subring of $k(X)$.

Definitions Suppose $A \subseteq B$ are commutative rings and $1_B \in A$.

- (1) An element $b \in B$ is *integral over A* if there is a number $n \in \mathbb{Z}^+$ and $\{\alpha_i\}_0^{n-1} \subset A$ such that

$$b^n + \alpha_{n-1}b^{n-1} + \dots + \alpha_0 = 0.$$

This equation is called an *integral dependence relation of b over A* .

- (2) B is *integral over A* if every element of B is integral over A .
- (3) The *integral closure \bar{A} of A in B* is the set of all elements of B which are integral over A .
- (4) If $\bar{A} = A$, then A is *integrally closed in B* .

By Corollary 5.3 of Atiyah and Macdonald [1], the integral closure of A in B is a ring.

Definitions Suppose that X is an affine variety.

- (1) X is a *normal variety* if $k[X]$ is integrally closed in $k(X)$.
- (2) A *normalization* of X is an irreducible normal variety X^ξ and a regular birational map $\xi: X^\xi \rightarrow X$, where $k[X^\xi]$ is integral over $\xi^*(k[X])$.

If X is an affine variety and $p \in X$, then the quotient $\mathfrak{m}_p/\mathfrak{m}_p^2$ has the structure of a k -vector space.

Definitions Suppose that X is an affine variety.

- (1) A point $p \in X$ is *non-singular* if $\dim(\mathfrak{m}_p/\mathfrak{m}_p^2)$ equals the dimension of X .
- (2) X is *non-singular* if every point in X is non-singular.

Theorem 1 in Chapter II, Section 5.1 of Shafarevich [23] states that non-singular affine varieties are normal.

If \mathfrak{m}_p is principal, then $\dim(\mathfrak{m}_p/\mathfrak{m}_p^2) = 1$. Theorem 2 in Chapter II, Section 5.1 of [23] implies that if X is a normal affine algebraic curve and $p \in X$, then \mathfrak{m}_p is principal. Thus, we have the following well-known theorem.

Theorem 2.1 *Suppose X is an irreducible affine algebraic curve. X is non-singular if and only if X is normal.*

The following theorem is a direct consequence of Theorems 4 and 5 in Chapter II, Section 5.2 in [23] (and the first part of the proof of Theorem 4).

Theorem 2.2 *If X is an irreducible affine algebraic curve, then X has a normalization $\xi: X^\xi \rightarrow X$. Moreover, the normalization is unique, affine and its coordinate ring is the integral closure of $\xi^*(k[X])$.*

The projective coordinates on projective space \mathbb{P}^n give distinguished open affine subsets $\{U_i\}_0^n$, which cover \mathbb{P}^n . So if $X \subset \mathbb{P}^n$ is an irreducible projective variety, then we have the distinguished affine open subsets $U_i \cap X$, which cover X . We say that X is non-singular if $U_i \cap X$ is non-singular for every $i = 0, \dots, n$.

Definition Suppose that X is an irreducible affine curve and let $\xi: X^\xi \rightarrow X$ the normalization of X . As in [14, Chapter 6], there is a smooth projective curve \tilde{X} (unique up to isomorphism) so that X^ξ is isomorphic to an open set in \tilde{X} . The projective variety \tilde{X} is called the *smooth projective model* for X .

Henceforth, we identify X^ξ with its image in \tilde{X} and we let $\iota: \tilde{X} \dashrightarrow X^\xi$ be the rational map that is the identity on X^ξ .

Definition The *ideal points* of X are the points in the set $\mathcal{I}(X) = \tilde{X} - X^\xi$. It follows from the uniqueness of normalizations and smooth projective models that $\mathcal{I}(X)$ is well-defined.

We have dominant birational maps

$$\tilde{X} \xrightarrow{\iota} X^\xi \xrightarrow{\xi} X.$$

The induced maps

$$k(\tilde{X}) \xleftarrow{\iota^*} k(X^\xi) \xleftarrow{\xi^*} k(X)$$

are isomorphisms. Moreover, $\xi^*(k[X]) \subseteq k[X^\xi]$.

Now suppose that Y is an affine variety and $\varphi: X \rightarrow Y$ is a regular map with $\overline{\varphi(X)} = Y$. Then $\varphi^*: k(Y) \rightarrow k(X)$ is a field monomorphism and $\varphi^*(k[Y]) \subseteq k[X]$.

Definition A *hole* in $\varphi: X \rightarrow Y$ is a point $\hat{p} \in \mathcal{I}(X)$ such that $(\varphi\xi\iota)^*(k[Y]) \subseteq \mathcal{O}_{\tilde{X}, \hat{p}}$.

Remark If \hat{p} is a hole in $\varphi: X \rightarrow Y$, since $\hat{p} \notin X^\xi$, there is an element $f \in k[X]$ with $(\xi\iota)^*(f) \notin \mathcal{O}_{\tilde{X}, \hat{p}}$. Also, if φ is a birational map, then φ is surjective if and only if φ has no hole.

Lemma 2.3 If $\varphi: X \rightarrow Y$ has a hole, then $k[X]$ is not integral over $\varphi^*(k[Y])$.

Proof Suppose \hat{p} is a hole. Take a distinguished open affine set $U_i \subset \mathbb{P}^n$ with $\hat{p} \in U_i$. Set $X_{\hat{p}} = U_i \cap \tilde{X}$. By Theorem 2.1, $X_{\hat{p}}$ is a non-singular affine curve so $k[X_{\hat{p}}]$ is integrally closed. Recall that $\mathcal{O}_{X_{\hat{p}}, \hat{p}}$ is isomorphic to the localization $k[X_{\hat{p}}]_{\mathfrak{m}_{\hat{p}}}$. Proposition 5.13 of [1] gives that this localization is integrally closed. The inclusion-induced isomorphism $k(\tilde{X}) \rightarrow k(X_{\hat{p}})$ restricts to an isomorphism $\mathcal{O}_{\tilde{X}, \hat{p}} \rightarrow \mathcal{O}_{X_{\hat{p}}, \hat{p}}$. Hence $\mathcal{O}_{\tilde{X}, \hat{p}}$ is integrally closed.

The point \hat{p} is a hole in $\varphi: X \rightarrow Y$ so $(\varphi\xi\iota)^*(k[Y]) \subseteq \mathcal{O}_{\tilde{X}, \hat{p}}$. Since $\mathcal{O}_{\tilde{X}, \hat{p}}$ is integrally closed, every element of $k(\tilde{X})$ that is integral over $(\varphi\xi\iota)^*(k[Y])$ is an element of $\mathcal{O}_{\tilde{X}, \hat{p}}$. We have $f \in k[X]$ with $(\xi\iota)^*(f) \notin \mathcal{O}_{\tilde{X}, \hat{p}}$, hence $(\xi\iota)^*(k[X])$ is not integral over $(\varphi\xi\iota)^*(k[Y])$ and so $k[X]$ is not integral over $\varphi^*(k[Y])$. \square

Theorem 2.4 Suppose X is an irreducible affine algebraic curve and $\varphi: X \rightarrow Y$ is a regular map with $\overline{\varphi(X)} = Y$. Then φ has no hole if and only if $k[X]$ is integral over $\varphi^*(k[Y])$.

Proof By Lemma 2.3, we need only show that if φ has no hole, then $k[X]$ is integral over $\varphi^*(k[Y])$.

Assume, to the contrary, that $k[X]$ is not integral over $\varphi^*(k[Y])$. Since ξ^* is injective, this implies that $k[X^\xi]$ is not integral over $(\varphi\xi)^*(k[Y])$. Taking integral closures in $k(X^\xi)$ we have

$$k[X^\xi] = \overline{k[X^\xi]} \not\supseteq \overline{(\varphi\xi)^*(k[Y])}.$$

Take $f \in k[X^\xi] - \overline{(\varphi\xi)^*(k[Y])}$. By the structure theorem of integrally closed noetherian rings (Mumford [20]), there is a valuation ring $R \subset k(X^\xi)$ with $f \notin R$ and $k \subset \overline{(\varphi\xi)^*(k[Y])} \subseteq R$.

Claim $\iota^*(R) = \mathcal{O}_{\tilde{X}, \hat{p}}$ for some $\hat{p} \in \tilde{X}$.

Using the claim, $\iota^*(f) \notin \mathcal{O}_{\tilde{X}, \hat{p}}$ so $\hat{p} \in \mathcal{I}(X)$. Moreover, $(\varphi\xi)^*k[Y] \subseteq R$ so

$$(\varphi\xi\iota)^*(k[Y]) \subseteq \iota^*(R) = \mathcal{O}_{\tilde{X}, \hat{p}}.$$

That is, \hat{p} is a hole in φ , a contradiction.

The claim follows from Corollary 6.6 of [14] since it gives an open set X_R in \tilde{X} and a point $\hat{p} \in X_R$ such that $\iota^*(R) = \mathcal{O}_{X_R, \hat{p}} = \mathcal{O}_{\tilde{X}, \hat{p}}$. □

It is well-known that, in this setting, $k[X]$ is integral over $f^*(k[Y])$ if and only if $k[X]$ is a finitely generated $f^*(k[Y])$ -module (see for example Proposition 5.1 and Corollary 5.2 of [1]). Hence, we have the following immediate corollary.

Corollary 2.5 *Suppose X is an irreducible affine algebraic curve and $\varphi: X \rightarrow Y$ is a regular map with $\overline{\varphi(X)} = Y$. Then φ has no hole if and only if $k[X]$ is a finitely generated $\varphi^*(k[Y])$ -module.*

Remarks Suppose that $k[X]$ is a finitely generated $\varphi^*(k[Y])$ -module.

- (1) Since X is irreducible, $k[X]$ has no zero divisors. Hence $k[X]$ is a torsion free $\varphi^*(k[Y])$ -module.
- (2) We can be more concrete about a basis for $k[X]$ as a $\varphi^*(k[Y])$ -module. Let $\{x_i\}_1^m$ be coordinate functions for X . By Theorem 2.4, each x_i is integral over $\varphi^*(k[Y])$. Let n_i be the degree of an integral dependence for x_i and define $\mathcal{S} = \{x_1^{\alpha_1} \cdots x_m^{\alpha_m} \mid 0 \leq \alpha_i < n_i\}$. Every element of $k[X]$ may be expressed as a $\varphi^*(k[X])$ -linear combination of the elements from the finite set \mathcal{S} . (See Proposition 2.16 of [1].)

3 Character varieties, boundary slopes and closed essential surfaces

Definition A *knot manifold* is a connected, compact, irreducible, orientable 3–manifold whose boundary is an incompressible torus.

Let N be a knot manifold and $\Gamma = \pi_1(N)$. Denote the set of $\mathrm{SL}_2\mathbb{C}$ –representations of Γ as $R(N)$ and the set of characters of representations in $R(N)$ as $X(N)$. Let $t: R(N) \rightarrow X(N)$ be the map that takes representations to their characters. In Culler and Shalen [10], it is shown that $R(N)$ and $X(N)$ are affine algebraic sets defined over \mathbb{C} and the map t is regular. We will refer to $R(N)$ and $X(N)$ as the *representation variety* and *character variety* for N .

Culler and Shalen revealed deep connections between essential surfaces in N and the character variety $X(N)$. We briefly outline some of their results below. For more background, see [10], the survey article Shalen [25] or [9, Chapter 1].

Definitions Suppose that X is a non-empty algebraic subset of $X(N)$.

- (1) Given $\gamma \in \Gamma$, the *trace function* for γ on X is the regular function $I_\gamma \in \mathbb{C}[X]$ defined by $I_\gamma(\chi) = \chi(\gamma)$.
- (2) Let $T(X)$ be the subring (with 1) in $\mathbb{C}[X]$ generated by $\{I_\gamma \mid \gamma \in \Gamma\}$. $T(X)$ is called the *trace ring* for X .

The following proposition gives that, as a ring, $T(X)$ is finitely generated.

Proposition 3.1 (Corollary 4.1.2 of González-Acuña and Montesinos-Amilibia [12])
Let $\{\gamma_i\}_1^n$ be a generating set for Γ . Then $T(X)$ is generated, as a ring, by the constant function 1 along with the functions in the set

$$\{I_V \mid V = \gamma_{j_1} \cdots \gamma_{j_k}, \text{ where } 1 \leq k \leq 3 \text{ and } 1 \leq j_1 < \cdots < j_k \leq n\}.$$

The smallest \mathbb{C} –algebra containing $T(X)$ is the coordinate ring $\mathbb{C}[X]$. Therefore, a generating set $\{\gamma_i\}_1^n$ for Γ gives an embedding of X into \mathbb{C}^{2^n-1} by taking the functions I_V to be coordinate functions. It is straightforward to see that under this embedding, $X(N)$ is cut out by polynomials with coefficients in \mathbb{Z} .

We have a regular map $\partial: X(N) \rightarrow X(\partial N)$ from $X(N)$ to the character variety for the peripheral subgroup (well-defined up to conjugation) of Γ given by restricting characters. For a non-empty algebraic subset X of $X(N)$, let ∂X denote the Zariski closure of $\partial(X)$.

- Definitions** (1) The unoriented isotopy class of an essential simple closed curve in ∂N is called a *slope*. We denote the set of slopes on N as S .
- (2) A *boundary slope* is a slope that is realized as a boundary component of an essential surface in N .

Each slope corresponds to a pair $\{\pm a\} \subset H_1(\partial N; \mathbb{Z})$. The inverse of the Hurewicz isomorphism is an isomorphism $H_1(\partial N; \mathbb{Z}) \rightarrow \pi_1 \partial N$. This gives a monomorphism $e: H_1(\partial N; \mathbb{Z}) \rightarrow \Gamma$, which is well-defined up to conjugation. Since traces are invariant under inversion and conjugation, the function $\{\pm a\} \mapsto I_{e(a)}$ is well-defined. When $\alpha = \{\pm a\}$ is a slope we write $I_\alpha = I_{e(a)}$.

Assume now that $X \subseteq X(N)$ is an irreducible affine curve and let

$$\tilde{X} \xrightarrow{\iota} X^\xi \xrightarrow{\xi} X$$

be the corresponding maps and varieties as defined in Section 2. The following theorem is well known and fundamental; see Theorem 2.2.1 and Proposition 2.3.1 of [10]. It is a translation of Theorem 1.1 into the language of Sections 2 and 3 of this paper.

Theorem 3.2 (Culler and Shalen) *For every ideal point \hat{x} of X , there is an associated non-empty essential surface Σ in N .*

- (1) Σ may be chosen to have empty boundary if and only if

$$(\partial \xi \iota)^*(\mathbb{C}[\partial X]) \subseteq \mathcal{O}_{\tilde{X}, \hat{x}}.$$

- (2) Otherwise, there exists a unique slope α such that $I_\alpha \in \mathcal{O}_{\tilde{X}, \hat{x}}$. In this case, every component of $\partial \Sigma$ represents the slope α .

Theorem 3.2 is broadly applicable. For instance, Kronheimer and Mrowka show that if N is the exterior of a non-trivial knot in S^3 , then $X(N)$ contains a curve with infinitely many irreducible characters [17]. Also, if the interior of N admits a complete hyperbolic structure with finite volume and χ_ρ is the character of a discrete faithful representation, then there is a unique algebraic component $X_0 \subseteq X(N)$ that contains χ_ρ . Furthermore, X_0 is a curve (see Thurston [26] and Shalen [25]). We refer to such a curve as a *hyperbolic curve*.

- Definitions** (1) Suppose that $X \subseteq X(N)$ is an irreducible affine curve and \hat{x} is an ideal point of X . A non-empty essential surface $\Sigma \subset N$ is *associated to \hat{x}* if it is contained in a surface given by \hat{x} and Theorem 3.2.
- (2) Suppose that X is an algebraic subset of $X(N)$. A surface Σ is *detected by X* if there is an ideal point \hat{x} of an irreducible affine curve in X so that Σ is associated to \hat{x} .

- (3) If an essential surface $\Sigma \subset N$ is detected by X (associated to \hat{x}) and $\partial\Sigma \neq \emptyset$ the boundary slope represented by a component of $\partial\Sigma$ is *detected* by X (associated to \hat{x}). The slope is *weakly* or *strongly* detected (associated) depending on whether \hat{x} satisfies case (1) or case (2) of Theorem 3.2, respectively.

Remark It is natural to ask if, whenever N contains a closed essential surface, there is a closed essential surface in N detected by $X(N)$. The author is not certain if the answer is known to be no, however there are compelling reasons to believe that the answer is no; see for example Chesebro and Tillmann [5] or Remark 5.1 in Dunfield [11].

We conclude this section with some applications of the work in Section 2.

Theorem 3.3 *Suppose N is a knot manifold and X is an irreducible algebraic subset of $X(N)$. The following are equivalent.*

- (1) X does not detect a closed essential surface.
- (2) $\dim(X) = \dim(\partial X) = 1$ and $\partial: X \rightarrow \partial X$ does not have a hole.
- (3) $\mathbb{C}[X]$ is integral over $\partial^*(\mathbb{C}[\partial X])$.
- (4) $\mathbb{C}[X]$ is a finitely generated $\partial^*(\mathbb{C}[\partial X])$ -module.

Proof As mentioned earlier, conditions (3) and (4) are equivalent by Proposition 5.1 and Corollary 5.2 of [1].

If $\dim(X) > \dim(\partial X)$, then $\mathbb{C}[X]$ is transcendental over $\partial^*(\mathbb{C}[\partial X])$ and so condition (3) cannot hold. The inequality $\dim(X) > \dim(\partial X)$ also implies that X contains a curve C to which Theorem 3.2 applies. This yields a closed essential surface detected by X . Hence, conditions (2) and (3) both imply that $\dim(X) = \dim(\partial X)$.

We have established that each of the four conditions implies that $\dim(X) = \dim(\partial X)$. By Proposition 2.4 of [6], $\dim(X) \geq 1$. Also $\dim(\partial X) \leq 1$, otherwise for any slope α on ∂N , there is a curve in X to which Theorem 3.2 can be applied to give an essential surface in N with boundary slope α . This contradicts Hatcher's theorem [15] that N has only finitely many boundary slopes. So, if any of conditions (1) through (4) hold, then $\dim(X) = \dim(\partial X) = 1$.

The theorem now follows from Theorems 2.4, 3.2 and Corollary 2.5. □

Given a trace function $I_\gamma \in \mathbb{C}[X]$, let $\mathbb{C}[I_\gamma]$ denote the \mathbb{C} -subalgebra of $\mathbb{C}[X]$ generated by I_γ . Consider the regular map $I_\gamma: X \rightarrow \mathbb{C}$ and the induced map $I_\gamma^*: \mathbb{C}[x] \rightarrow \mathbb{C}[X]$. If I_γ is non-constant on X , then I_γ^* is injective and $\mathbb{C}[I_\gamma]$ is naturally isomorphic to $\mathbb{C}[x]$. Moreover, $\mathbb{Z}[x]$ is naturally isomorphic to the \mathbb{Z} -submodule $\mathbb{Z}[I_\gamma] \subseteq T(X)$ generated by all finite powers of I_γ . For instance, if α is a slope that is not detected by X , since $\dim(X) \geq 1$, Theorem 3.2 implies that I_α is non-constant on X .

Theorem 3.4 Suppose N is a knot manifold, X is an irreducible algebraic subset of $X(N)$ and α is a slope. The following are equivalent.

- (1) X does not detect a closed essential surface and α is not detected by X .
- (2) $\mathbb{C}[X]$ is integral over $\mathbb{C}[I_\alpha]$.
- (3) As a $\mathbb{C}[I_\alpha]$ -module, $\mathbb{C}[X]$ is finitely generated and free.

Proof As with conditions (3) and (4) of the previous theorem, we know that (3) implies (2) and that (2) implies that $\mathbb{C}[X]$ is a finitely generated $\mathbb{C}[I_\alpha]$ -module. $\mathbb{C}[X]$ is an integral domain so, as a $\mathbb{C}[I_\alpha]$ -module, $\mathbb{C}[X]$ is torsion free. $\mathbb{C}[I_\alpha]$ is a PID so $\mathbb{C}[X]$ is a free $\mathbb{C}[I_\alpha]$ -module.

It remains to show that (1) and (2) are equivalent.

Assume first that (2) holds. Theorem 3.3 shows that X does not detect a closed essential surface and $\dim(X) = 1$. Hence I_α is not constant. We have the regular map $I_\alpha: X \rightarrow \mathbb{C}$ and $\overline{I_\alpha(X)} = \mathbb{C}$. Since $\mathbb{C}[X]$ is integral over $\mathbb{C}[I_\alpha]$, Theorem 2.4 shows that $I_\alpha: X \rightarrow \mathbb{C}$ does not have a hole. By Theorem 3.2, α is not strongly detected by X . Since X does not detect a closed essential surface, α cannot be weakly detected by X .

Now suppose that (1) holds. As in the proof of Theorem 3.3, we have that $\dim(X) = 1$. Consider the regular map $I_\alpha: X \rightarrow \mathbb{C}$. Either $\overline{I_\alpha(X)} = \mathbb{C}$ or I_α is constant on X . But since $\dim(X) = 1$, Theorem 3.2 implies that if I_α is constant on X , then α is strongly detected by X or X detects a closed essential surface. So we must have $\overline{I_\alpha(X)} = \mathbb{C}$.

By Theorem 2.4, it suffices to show that the regular map I_α does not have a hole. Again, we appeal to Theorem 3.2 and notice that if I_α has a hole, then either α is strongly detected or X detects a closed essential surface. □

Definition Let $X \subseteq X(N)$ be an irreducible algebraic subset. The \mathbb{C} -rank function is the map

$$\text{Rk}_X^{\mathbb{C}}: \mathcal{S} \rightarrow \mathbb{Z}^+ \cup \{\infty\},$$

where $\text{Rk}_X^{\mathbb{C}}(\alpha)$ is the rank of $\mathbb{C}[X]$ as a $\mathbb{C}[I_\alpha]$ -module.

Remarks Using Theorem 3.4, we make the following observations.

- (1) If X does not detect a closed essential surface, $\text{Rk}_X^{\mathbb{C}}(\alpha) = \infty$ if and only if α is strongly detected by X .
- (2) X detects a closed essential surface if and only if $\text{Tr}_X^{\mathbb{C}}(\mathcal{S}) = \{\infty\}$.
- (3) By Lemma 1.4.4 of [9], there are only finitely many boundary slopes strongly detected by X . Avoiding this finite set, choose $\alpha \in \mathcal{S}$. Then X detects a closed essential surface if and only if $\text{Rk}_X^{\mathbb{C}}(\alpha) = \infty$.

For X an irreducible algebraic component of $X(N)$, we define X° to be the union of the irreducible components X' of $X(N)$ such that

- (1) X' detects a closed essential surface if and only if X detects a closed essential surface and
- (2) for every slope α , X' detects α if and only if X detects α .

Proposition 3.5 *If X is an irreducible algebraic component of $X(N)$, then X° is defined over \mathbb{Q} .*

Proof By a theorem of Weil [18, Chapter III, Theorem 7], it suffices to prove that X° is invariant under the action of $\text{Aut}(\mathbb{C})$ on $X(N)$ (see [6, Proposition 2.3], and Boyer and Zhang [3, Section 5]).

First, we assume that X does not detect a closed essential surface. Theorem 3.4 implies that X° is the union of the irreducible algebraic components X' of $X(N)$ such that, for every slope α , $\mathbb{C}[X']$ is integral over $\mathbb{C}[I_\alpha]$ if and only if $\mathbb{C}[X]$ is integral over $\mathbb{C}[I_\alpha]$.

Let $\phi \in \text{Aut}(\mathbb{C})$, X' an irreducible component of X° , and $\alpha \in \mathcal{S}$. Define $X'' = \phi(X')$. The set $\phi(X')$ is an irreducible algebraic component of $X(N)$. To prove the proposition we need only show that $\mathbb{C}[X'']$ is integral over $\mathbb{C}[I_\alpha]$ if and only if $\mathbb{C}[X']$ is integral over $\mathbb{C}[I_\alpha]$.

The automorphism ϕ determines an automorphism on any complex polynomial ring by acting on the coefficients. This automorphism descends to an isomorphism $\phi: \mathbb{C}[X'] \rightarrow \mathbb{C}[X'']$. Since $\phi: \mathbb{C} \rightarrow \mathbb{C}$ restricts to the identity on \mathbb{Q} and I_α is represented by a polynomial with integer coefficients we have $\phi(I_\alpha) = I_\alpha$. Therefore, if $p \in \mathbb{C}[I_\alpha]$, then $\phi(p) \in \mathbb{C}[I_\alpha]$. So if $f \in \mathbb{C}[X']$ is integral over $\mathbb{C}[I_\alpha]$, we can apply ϕ to an integral dependence relation for f over $\mathbb{C}[I_\alpha]$ to obtain one for $\phi(f)$ over $\mathbb{C}[I_\alpha]$. To prove the converse, we apply ϕ^{-1} to any integral dependence relation for $\mathbb{C}[X'']$ over $\mathbb{C}[I_\alpha]$.

The case when X does detect a closed essential surface follows from the above argument along with Lemma 5.3 of [3]. \square

Definition Suppose $X \subseteq X(N)$ is an algebraic set. The *rational trace ring* $T_{\mathbb{Q}}(X)$ is the smallest \mathbb{Q} -algebra that contains $T(X)$.

Theorem 3.6 *Suppose N is a knot manifold, X is an irreducible algebraic subset of $X(N)$ and $\alpha \in \mathcal{S}$. The following are equivalent.*

- (1) X does not detect a closed essential surface and α is not detected by X .

- (2) $T_{\mathbb{Q}}(X)$ is integral over $\mathbb{Q}[I_{\alpha}]$.
- (3) As a $\mathbb{Q}[I_{\alpha}]$ -module, $T_{\mathbb{Q}}(X)$ is a finitely generated and free.

Proof The first paragraph of the proof of Theorem 3.4 shows that (2) and (3) are equivalent. Theorem 3.4 shows that (2) implies (1).

It remains to show that (1) implies (2). Suppose then that X does not detect a closed essential surface and α is not detected by X . $T_{\mathbb{Q}}(X)$ is generated by $T(X)$ as a \mathbb{Q} -algebra, so it suffices to show that elements of $T(X)$ are integral over $\mathbb{Q}[I_{\alpha}]$.

Let $\{X_j\}_1^n$ be the set of irreducible algebraic components of X° and take $f \in T(X)$. The map $\mathbb{C}[X^{\circ}] \rightarrow \mathbb{C}[X]$ induced by inclusion is given by restriction and is surjective. Take $F \in \mathbb{C}[X^{\circ}]$ such that $F|_X = f$. Let $\pi: X^{\circ} \rightarrow \mathbb{C}^2$ be the map (F, I_{α}) . Let (x, y) be the coordinates on $\text{Im}(\pi)$ determined by $x\pi = F$ and $y\pi = I_{\alpha}$.

Fix $j \in \{1, \dots, n\}$. By Theorem 3.3, $I_{\alpha}: X_j \rightarrow \mathbb{C}$ is non-constant and $\overline{\pi(X_j)}$ is an irreducible plane curve. Let $P_j \in \mathbb{C}[x, y]$ be an irreducible polynomial that defines $\overline{\pi(X_j)}$. X° is defined over \mathbb{Q} (Proposition 3.5) and π is given by polynomials with \mathbb{Z} -coefficients, so we may assume that

$$P = \prod_{j=1}^n P_j \in \mathbb{Z}[x, y].$$

For each j , Theorem 3.4 gives that $F|_{X_j}$ is integral over $\mathbb{C}[I_{\alpha}]$. This means that there is a polynomial in $\mathbb{C}[x, y]$ that is zero on $\overline{\pi(X_j)}$ and monic as a polynomial in $(\mathbb{C}[x])[y]$. Select one such polynomial p_j with minimal degree. Then p_j is irreducible and must differ from P_j only by multiplication by some $\alpha_j \in \mathbb{C}$. We have

$$P = \prod P_j = \left(\prod \alpha_j\right) \cdot \left(\prod p_j\right).$$

Hence $\prod \alpha_j \in \mathbb{Z}$ and $(\prod \alpha_j^{-1}) \cdot P$ gives an integral dependence relation for f over $\mathbb{Q}[I_{\alpha}]$. □

Definition Suppose $X \subseteq X(N)$ is an irreducible algebraic subset. The \mathbb{Q} -rank function is the map

$$\text{Rk}_X^{\mathbb{Q}}: \mathcal{S} \rightarrow \mathbb{Z}^+ \cup \{\infty\},$$

where $\text{Rk}_X^{\mathbb{Q}}(\alpha)$ is the rank of $T_{\mathbb{Q}}(X)$ as a $\mathbb{Q}[I_{\alpha}]$ -module.

It will require more work to show that there are related theorems which work over \mathbb{Z} . We begin by establishing some lemmas concerning valuations.

4 Valuations

Lemma 4.1 Suppose $v: F^\times \rightarrow \Lambda$ is a valuation on the field F . Assume that

$$cx^k = \sum_{i=0}^{k-1} a_i x^i$$

for some $c, x, a_i \in F$ and $k \in \mathbb{Z}^+$ such that $c \neq 0$, $v(c) = 0$ and $v(a_i) \geq 0$ for every i . Then $v(x) \geq 0$.

Proof If every a_i is zero, then $x = 0$ and so $v(x) = \infty$, so we may assume that at least one of the a_i is non-zero. Let j be such that $v(a_j) + jv(x)$ is minimal in the set $\{v(a_i) + iv(x) \mid 0 \leq i < k\}$. We have

$$kv(x) = v(c) + kv(x) \geq v(a_j) + jv(x)$$

so

$$(k - j)v(x) \geq v(a_j) \geq 0.$$

Hence $v(x) \geq 0$. □

The following lemma is essentially Lemma 2.2 of [7].

Lemma 4.2 Suppose $p \in \mathbb{Z}$ is a prime and $h \in \mathbb{Z}[t]$ is irreducible over \mathbb{Z} and of the form

$$h(t) = c_0 + c_1t + \dots + c_{k-1}t^{k-1} + c_k p^r t^k,$$

where $(c_k, p) = 1$ and $c_k \neq \pm 1$. Let $b \in \mathbb{C}$ be any root of h . Then there is a valuation v on $\mathbb{Q}(b)$ with $v(p) = 0$ and $v(b) < 0$.

Proof Since $(c_k, p) = 1$ and $h \in \mathbb{Z}[t]$ we know that r is an integer and at least zero. Now, for $i \in \{0, \dots, k - 1\}$, define $a_i = c_i p^{k-1-i}$. We have $p^{(k-1)r} c_i = a_i (p^r)^i$, so

$$p^{(k-1)r} h(t) = a_0 + a_1(p^r t) + \dots + a_{k-1}(p^r t)^{k-1} + c_k (p^r t)^k$$

Set $d = p^r b$ and

$$h^*(t) = a_0 + a_1 t + \dots + a_{k-1} t^{k-1} + c_k t^k.$$

Then $h^* \in \mathbb{Z}[t]$ and $h^*(d) = 0$. We have

$$c_k d^k = \sum_{i=0}^{k-1} a_i d^i.$$

Let v_p be an extension of the p -adic valuation to $\mathbb{Q}(b)$. Since $(c_k, p) = 1$, $v_p(c_k) = 0$. Also, for every i , $a_i \in \mathbb{Z}$ so $v(a_i) \geq 0$. Hence, Lemma 4.1 implies that $v_p(d) \geq 0$.

Since h is irreducible over \mathbb{Z} and $\mathbb{Q}(b) = \mathbb{Q}(d)$, it follows that h^* is irreducible over \mathbb{Z} . Hence, neither b nor d is integral over \mathbb{Z} . By Corollary 5.2 of [1], we have a valuation v on $\mathbb{Q}(b)$ with $v(d) < 0$. The restriction of v to \mathbb{Q} cannot be the p -adic valuation and (again using Lemma 4.1) cannot be trivial. Therefore, $v|_{\mathbb{Q}} = v_q$ for some prime $q \in \mathbb{Z}$ that is different from p . Thus $v(p) = 0$. Also

$$v(b) = v(dp^{-r}) = v(d) - rv(p) = v(d) < 0. \quad \square$$

5 $T(X)$ as a $\mathbb{Z}[I_\alpha]$ -module

Throughout this section, N is a knot manifold and Γ is its fundamental group. Next, we introduce some terminology from Schanuel and Zhang [22].

Definition A representation $\rho: \Gamma \rightarrow \mathrm{SL}_2\mathbb{C}$ is *algebraic non-integral* if the image of ρ is in SL_2F , where F is a number field and $\chi_\rho(\gamma)$ is not an algebraic integer for some $\gamma \in \Gamma$. If ρ is an algebraic non-integral representation we abbreviate this by saying that ρ is an *ANI-representation*.

Similar to Theorem 3.2, the following result again follows from the work of Culler and Shalen. See Lemma 2 of [22].

Theorem 5.1 *For every ANI-representation ρ of Γ there is an associated non-empty essential surface $\Sigma \subset N$. Suppose that $\alpha \in \mathcal{S}$ is not a boundary slope. The surface Σ may be chosen to have empty boundary if and only if $I_\alpha(\chi_\rho)$ is an algebraic integer.*

Definitions (1) Suppose that ρ is an ANI-representation of Γ and $\Sigma \subset N$ is a non-empty essential surface. Σ is *associated to ρ* if it is contained in a surface given by ρ and Theorem 5.1.

(2) Suppose that X is an algebraic subset of $X(N)$. A surface Σ is *ANI-detected by X* if there is an ANI-representation ρ of Γ whose character lies on X and Σ is associated to ρ .

Proposition 5.2 *If X is an irreducible algebraic subset of $X(N)$ and N contains a closed essential surface that is ANI-detected by X , then N contains a closed essential surface detected by X .*

Proof Assume that X does not detect a closed essential surface and suppose for a contradiction that there is a closed essential surface in N associated to an ANI-representation $\rho: \Gamma \rightarrow \mathrm{SL}_2 F$ with $\chi_\rho \in X$. Take $\gamma \in \Gamma$ with $\chi_\rho(\gamma)$ non-integral and choose $\alpha \in \mathcal{S}$ not a boundary slope. By Theorem 5.1, $\chi_\rho(\alpha)$ is an algebraic integer.

The integral closure of \mathbb{Z} in F is the intersection of all valuation rings of F [1, Corollary 5.22]. Thus, there is a valuation v on F with $v(I_\gamma(\chi_\rho)) < 0$ and $v(I_\alpha(\chi_\rho)) \geq 0$. By Theorem 3.6, there is a polynomial

$$f(x, y) = cx^r + \sum_{j=0}^{r-1} q_j(y)x^j$$

with $c \in \mathbb{Z} - \{0\}$, $q_j \in \mathbb{Z}[y]$ and $f(I_\gamma, I_\alpha) = 0$ on X . Since $v(I_\alpha(\chi_\rho)) \geq 0$, we know that $v(q_j(I_\alpha(\chi_\rho))) \geq 0$. But then, Lemma 4.1 implies that $v(I_\gamma(\chi_\rho)) \geq 0$, a contradiction. \square

Example 5.3 In [8], Cooper and Long ask whether there is a one-cusped manifold whose character variety detects a closed essential surface. This was answered by Tillmann in [27], where he presented a calculation which shows that the character variety of the Kinoshita–Terasaka knot (11n42) detects a closed essential surface. Together with data collected by Goodman, Heard and Hodgson [13], <http://www.ms.unimelb.edu.au/~snap/>, Proposition 5.2 gives many more examples.

Suppose that N is a one-cusped hyperbolic 3-manifold and let X_0 be an algebraic component of $X(N)$ that contains the character of a discrete faithful representation ρ_0 . By Theorem 5.1 and Proposition 5.2, if ρ_0 is an ANI-representation, then N contains a closed essential surface detected by $X(N)$.

For all manifolds in the Callahan–Hildebrand–Weeks census of cusped hyperbolic manifolds with up to 7 tetrahedra [4], and for all complements of hyperbolic knots and links up to 12 crossings, Goodman, Heard and Hodgson use the computer program Snap to attempt to (among other things) decide whether or not the holonomy representation is an ANI-representation. They find 252 such manifolds, 21 of which are complements of knots in S^3 (this is almost certainly not a complete list). The knots are 9a30, 9a31, 10a89, 10a96, 10a103, 11n97, 12n156, 12n245, 12n246, 12n260, 12n494, 12n508, 12n518, 12n600, 12n602, 12n604, 12n605, 12n694, 12n888, 12a1205 and 12a1288.

Roughly, the following theorem is proven by applying Theorem 3.6 and arguing as in [7].

Theorem 5.4 *Suppose N is a knot manifold, X is an irreducible algebraic subset of $X(N)$ and $\alpha \in \mathcal{S}$. The following are equivalent.*

- (1) X does not detect a closed essential surface and α is not detected by X .
- (2) $T(X)$ is integral over $\mathbb{Z}[I_\alpha]$.
- (3) $T(X)$ is a finitely generated $\mathbb{Z}[I_\alpha]$ -module.

Proof As with Theorem 3.6, we need only argue that (1) implies (2). Suppose that (1) is true and take $\gamma \in \Gamma$. Our goal is to show that I_γ is integral over $\mathbb{Z}[I_\alpha]$, so we may assume that I_γ is not everywhere zero on X . By Theorem 3.3, $\dim(X) = 1$ and by Theorem 3.4, I_α must be non-constant on X .

By Theorem 3.6, there is a polynomial $f(y, z) \in \mathbb{Z}[y, z]$ of the form

$$f(y, z) = cy^r + \sum_{j=0}^{r-1} q_j(z)y^j$$

with $q_j \in \mathbb{Z}[z]$ such that $c \neq 0$, $f(I_\gamma, I_\alpha)$ is the zero function on X and the greatest common divisor of the coefficients of f is one. Choose f among all such polynomials to have smallest possible total degree. Then, since I_α and I_γ are not everywhere zero on X , neither y nor z divides f .

Take $k \in \mathbb{N}$ large enough such that $f(y, xy^{-k})$ has no two terms with the same degree in y . Take $l \in \mathbb{Z}$ as small as possible such that

$$g(x, y) = y^l f(y, xy^{-k})$$

is a polynomial in $\mathbb{Z}[x, y]$. Then $g(x, y)$ is of the form

$$g(x, y) = cy^s + \sum_{j=0}^{s-1} a_j x^{t_j} y^j,$$

where the t_j are distinct integers, the greatest common divisor of the a_j is one, $g(I_\alpha I_\gamma^k, I_\gamma) = 0$ on X and neither x nor y divides g .

We know that I_α is non-constant on X so there must be a point $\hat{x} \in \tilde{X}$ with $I_\alpha(\hat{x}) = 0$. If $I_\alpha I_\gamma^k$ is constant on X , then $I_\alpha = KI_\gamma^{-k}$ for some $K \in \mathbb{C}$. Hence, \hat{x} is an ideal point of X . By Theorem 2.2.1 and Proposition 2.3.1 of [10], either X detects a closed essential surface or an essential surface with boundary slope α . Both are contradictions so $I_\alpha I_\gamma^k$ must be non-constant on X . Therefore, we may choose a prime p such that $\gcd(c, p) = 1$ and for every root b of $g(p, y)$ there is a character $\chi_\rho \in X$ with $\chi_\rho(\alpha) \cdot \chi_\rho(\gamma)^k = p$ and $\chi_\rho(\gamma) = b$.

Take

$$g(p, y) = \eta \cdot \prod_{j=0}^u h_j(y)$$

a complete factorization of $g(p, y)$ over \mathbb{Z} . So $\eta \in \mathbb{Z}$ and each h_j is irreducible over \mathbb{Z} . We claim that c divides η . The leading coefficient of $g(p, y)$ is c . If we denote the leading coefficient of h_j as c_j , we have $c = \eta c_0 \cdots c_u$. If c doesn't divide η , then there is some c_i with $\gcd(\alpha, c_i) > 1$. Write $c_i = p^t d$, where $\gcd(p, d) = 1$. Since $\gcd(c, p) = 1$ we must have $\gcd(c, d) > 1$, in particular $d \neq \pm 1$. Let b be a root of h_i . By our choice of p , there is $\chi_\rho \in X$ which corresponds to the solution $g(p, b)$. Using Hilbert's Nullstellensatz, we may assume that the entries of the matrices in $\rho(\pi_1 N)$ lie in a number field F . By Lemma 4.2, we have a valuation v on $\mathbb{Q}(b)$ with $v(p) = 0$ and $v(b) < 0$. Take an extension of v to F . We have $v(I_\gamma(\chi_\rho)) < 0$ and

$$0 = v(I_\alpha(\chi_\rho)I_\gamma(\chi_\rho)^k) = v(I_\alpha(\chi_\rho)) + k \cdot v(I_\gamma(\chi_\rho)).$$

Since $k \geq 0$ we must have $v(I_\alpha(\chi_\rho)) \geq 0$. Hence, N contains a closed essential surface that is ANI-detected by X . Proposition 5.2 shows that this is a contradiction, so we must have that c divides η .

The constant η divides every coefficient of $g(p, y)$ and c divides η , so c divides every coefficient of $g(p, y)$. But the coefficient for z^j is $a_j p^{t_j}$ and $\gcd(c, p) = 1$. Hence c divides each a_j . The only integers that divide every a_j are ± 1 . Therefore $f(I_\gamma, I_\alpha)$ is an integral dependence relation for I_γ over $\mathbb{Z}[I_\alpha]$. \square

Definition Let $X \subseteq X(N)$ be an irreducible algebraic subset. The \mathbb{Z} -rank function is the map

$$\text{Rk}_X^{\mathbb{Z}}: \mathcal{S} \rightarrow \mathbb{Z}^+ \cup \{\infty\},$$

where $\text{Rk}_X^{\mathbb{Z}}(\alpha)$ is the rank of $T(X)$ as a $\mathbb{Z}[I_\alpha]$ -module.

Corollary 5.5 Suppose N is a knot manifold, X is an irreducible algebraic subset of $X(N)$ that is defined over \mathbb{Q} and $\alpha \in \mathcal{S}$. The following are equivalent.

- (1) X does not detect a closed essential surface and α is not detected by X .
- (2) Every $f \in T(X)$ satisfies a monic irreducible polynomial with coefficients in $\mathbb{Z}[I_\alpha]$.

Proof By Theorem 3.4, we need only argue that (1) implies (2). Assume that X does not detect a closed essential surface and let f be a non-zero element of $T(X)$. By Theorem 3.3, X is a curve. Since X does not detect a closed essential surface, I_α is non-constant on X . Let V be the Zariski closure of the image of X under the map (f, I_α) . V must be an irreducible affine curve defined over \mathbb{Q} . Let $p \in \mathbb{Q}[x, y]$ be a defining equation for V . By multiplying by an integer, we may assume that $p \in \mathbb{Z}[x, y]$ and that if c divides every coefficient of p , then $c = \pm 1$. The proof of Theorem 5.4 shows that p is monic as a polynomial in $\mathbb{Z}[I_\alpha]$. Since V is irreducible, p is irreducible. \square

Definition A knot manifold is called *small* if it does not contain a closed essential surface.

Corollary 5.6 Let X be an irreducible algebraic subset of $X(N)$, where N is a small knot manifold. A slope α is detected by X if and only if $\text{Rk}_X^{\mathbb{Z}}(\alpha) \neq \infty$.

6 $\text{PSL}_2\mathbb{C}$ -character varieties

The theorems from Sections 3 and 5 also apply in the $\text{PSL}_2\mathbb{C}$ setting after making appropriate definitions and using virtually identical arguments. See Boyer and Zhang [2] for details in what follows.

As usual, let N be a compact irreducible orientable 3-manifold with torus boundary and let $\Gamma = \pi_1 N$. Denote the set of $\text{PSL}_2\mathbb{C}$ -representations of Γ as $\bar{R}(N)$. $\text{PSL}_2\mathbb{C}$ acts on $\bar{R}(N)$ by conjugation. Let $\bar{t}: \bar{R}(N) \rightarrow Y(N)$ denote the corresponding algebro-geometric quotient. $\bar{R}(N)$ and $Y(N)$ are affine algebraic sets and the map \bar{t} is a surjective regular map. $Y(N)$ is called the $\text{PSL}_2\mathbb{C}$ -character variety for N and a point in $Y(N)$ is called a $\text{PSL}_2\mathbb{C}$ -character. As with the $\text{SL}_2\mathbb{C}$ -character variety, every irreducible algebraic component of $Y(N)$ has dimension at least one [6].

We would like to relate $Y(N)$ to $\text{SL}_2\mathbb{C}$ -character varieties and define $T(Y)$, where Y is an irreducible algebraic subset of $Y(N)$. First we claim that there is a well-defined equivalence class of \mathbb{Z}_2 -central extensions

$$(2) \quad 1 \rightarrow \mathbb{Z}_2 \rightarrow \hat{\Gamma} \rightarrow \Gamma \rightarrow 1$$

and a finite regular map from the $\text{SL}_2\mathbb{C}$ -character variety $X(\hat{\Gamma})$ of $\hat{\Gamma}$ to $Y(N)$ that contains Y in its image.

First note that if $\bar{\rho}_1, \bar{\rho}_2 \in \bar{R}(N)$ have the same image under \bar{t} , then the representations are either both reducible or are both irreducible. Hence we may refer to the points of Y as being either reducible or irreducible.

Suppose that every element of Y is reducible and choose $\bar{\chi} \in Y$ smooth in $Y(N)$. There is a diagonal representation $\bar{\rho} \in \bar{t}^{-1}(\bar{\chi})$. This representation determines an extension (2) and a lift $\hat{\rho}: \hat{\Gamma} \rightarrow \text{SL}_2\mathbb{C}$ of $\bar{\rho}$. Moreover, the isomorphism class of $\hat{\Gamma}$ is independent of our choices of $\bar{\chi}$ and $\bar{\rho}$. The natural epimorphisms $\text{SL}_2\mathbb{C} \rightarrow \text{PSL}_2\mathbb{C}$ and $\hat{\Gamma} \rightarrow \Gamma$ together induce a regular map $\phi: X(\hat{\Gamma}) \rightarrow Y(N)$. In fact, the image of ϕ is the quotient of $X(\hat{\Gamma})$ under the natural action of $H^1(\hat{\Gamma}; \mathbb{Z}_2)$. Moreover, $Y \subseteq \text{Im}(\phi)$.

Otherwise Y contains an irreducible character which is a smooth point of $Y(N)$. Let $\bar{\chi}$ be such a point and $\bar{\rho} \in \bar{t}^{-1}$. Exactly as before, we obtain an extension (2) and a lift

$\hat{\rho}$ of $\bar{\rho}$ to $\hat{\Gamma}$. Again, the isomorphism class of $\hat{\Gamma}$ is independent of our choices, we obtain a finite regular map $\phi: X(\hat{\Gamma}) \rightarrow Y(N)$, the image of ϕ is the quotient of $X(\hat{\Gamma})$ by $H^1(\hat{\Gamma}; \mathbb{Z}_2)$, and $Y \subseteq \text{Im}(\phi)$.

In either case, the induced map $\phi^*: \mathbb{C}[\text{Im}(\phi)] \rightarrow \mathbb{C}[X(\hat{\Gamma})]$ is injective. We define the trace ring $T(\text{Im}(\phi))$ to be

$$T(\text{Im}(\phi)) = (\phi^*)^{-1}(\text{Im}(\phi^*) \cap T(X(\hat{\Gamma}))).$$

The inclusion $Y \rightarrow \text{Im}(\phi)$ induces an epimorphism $\mathbb{C}[\text{Im}(\phi)] \rightarrow \mathbb{C}[Y]$. Define $T(Y)$ to be the image of $T(\text{Im}(\phi))$ under this epimorphism.

Note that if $\gamma \in \Gamma$ and $\hat{\gamma}_1, \hat{\gamma}_2 \in \hat{\Gamma}$ are the preimages of γ , then $I_{\hat{\gamma}_1}^2 = I_{\hat{\gamma}_2}^2$. It follows that there is a well-defined squared trace function $I_{\gamma}^2 \in T(Y)$.

To obtain results in the $\text{PSL}_2\mathbb{C}$ -setting corresponding to those in Sections 3 and 5, we use the $\text{PSL}_2\mathbb{C}$ -definitions rather than $\text{SL}_2\mathbb{C}$ -definitions and replace I_{α} with the squared trace function I_{α}^2 whenever I_{α} is not in the $\text{PSL}_2\mathbb{C}$ -trace ring.

Remark The equivalence classes of extensions (2) are in bijective correspondence with the elements of $H^2(\Gamma; \mathbb{Z}_2)$.

7 Ranks and examples

Throughout this section we assume that N is a knot manifold and $\Gamma = \pi_1 N$. For an irreducible algebraic set $X \subseteq X(N)$, observe that

$$(3) \quad \text{Rk}_X^{\mathbb{C}} \leq \text{Rk}_X^{\mathbb{Q}} \leq \text{Rk}_X^{\mathbb{Z}}.$$

Among other things, this section gives examples that show that these inequalities need not be equalities.

If R is a ring, M is an R -module, and $S \subset M$, we write $\langle S \rangle_R$ to denote the R -module generated by S .

7.1 Abelian curves

Suppose that $H_1(N; \mathbb{Z}) \cong \mathbb{Z}$. There is a curve $X_A \subseteq X(N)$ consisting of all characters of representations which that through $H_1(N; \mathbb{Z})$. Let $\alpha \in \Gamma$ be a peripheral element whose image in $H_1(N; \mathbb{Z})$ generates $H_1(N; \mathbb{Z})$.

Every character in X_A is the character of a diagonal representation and the image subgroup in $\text{SL}_2\mathbb{C}$ is generated by the image of α . It follows that every trace function $I_{\beta} \in T(X_A)$ is represented by a polynomial in $\mathbb{Z}[I_{\alpha}]$. Using the single coordinate I_{α} on X_A , we have $X_A = \mathbb{C}$. In particular, we have the following well-known proposition.

Proposition 7.1 Suppose that N is a knot manifold and $H_1(N; \mathbb{Z}) \cong \mathbb{Z}$. Let $X_A \subseteq X(N)$ be the curve consisting of all abelian representations of $\pi_1 N$. Then:

- (1) X_A has exactly one ideal point. This ideal point detects the unique boundary slope which is trivial in $H_1(N; \mathbb{Z})$.
- (2) $T(X_A) = \mathbb{Z}[I_\alpha]$.

So, by the proposition, $T(X_A)$ is a free $\mathbb{Z}[I_\alpha]$ -module with rank one.

7.2 Norm curves

Recall the following definition from [3].

Definition An algebraic curve component X of $X(N)$ is called a *norm curve component* if $I_\gamma: X \rightarrow \mathbb{C}$ is non-constant for every non-trivial peripheral element of Γ .

For example, if N is hyperbolic, there is a hyperbolic curve $X_0 \subseteq X(N)$. By Proposition 3.1.1 of [10], X_0 is a norm curve component.

Proposition 7.2 Suppose that N is a knot manifold and X is an irreducible algebraic subset of $X(N)$. Let α be a slope. If X is a norm curve component, then $\text{Rk}_X^{\mathbb{C}}(\alpha) \geq 2$.

Proof Suppose that X is a norm component and that $\text{Rk}_X^{\mathbb{C}}(\alpha) < 2$. The dimension of X is one, so we must have $\text{Rk}_X^{\mathbb{C}}(\alpha) = 1$. Hence, $f \cdot \mathbb{C}[I_\alpha] = \mathbb{C}[X]$ for some $f \in \mathbb{C}[X]$. Now

$$\mathbb{C}[I_\alpha] = f^{-1} f \cdot \mathbb{C}[I_\alpha] = f^{-1} \cdot \mathbb{C}[X] = \mathbb{C}[X].$$

Therefore, X has exactly one ideal point. On the other hand, [3, Proposition 4.5] and Theorem 3.2 show that X strongly detects at least two boundary slopes, so X must have more than one ideal point. □

7.3 Two-bridge knots

Suppose that K is a two bridge knot. Define $N = S^3 - K$ and $\Gamma = \pi_1 N$. Let $\langle \mu, \beta \mid \omega\beta = \mu\omega \rangle$ be the standard presentation for Γ as given in Section 4.5 of Maclachlan and Reid [19]. The element $\mu \in \Gamma$ is a meridian for the knot.

Suppose that X is an algebraic component of $X(N)$ which is defined over \mathbb{Q} . Let $x = I_\mu$ and $y = I_{\mu\beta}$ in $T(X)$. It is shown in Hatcher and Thurston [16] that N is

small and the slope represented by μ is not a boundary slope. By Corollary 5.5, we have a set of polynomials $\{p_j\}_{j=0}^n$ in $\mathbb{Z}[x]$, where X is given as the zero set in \mathbb{C}^2 of

$$P(x, y) = y^n - \sum_{j=0}^n p_j(x)y^j$$

and P is irreducible in $\mathbb{C}[x, y]$. Let $\mathcal{B} = \{y^j\}_{j=0}^{n-1} \subset T(X)$. Since P is zero in $T(X)$, \mathcal{B} generates $T(X)$ as a $\mathbb{Z}[x]$ -module, $T_{\mathbb{Q}}(X)$ as a $\mathbb{Q}[x]$ -module and $\mathbb{C}[X]$ as a $\mathbb{C}[x]$ -module. In particular,

$$(4) \quad \text{Rk}_X^{\mathbb{Z}}(\mu) \leq n.$$

Proposition 7.3 \mathcal{B} is a free basis for $\mathbb{C}[X]$ as a $\mathbb{C}[x]$ -module, $T_{\mathbb{Q}}(X)$ as a $\mathbb{Q}[x]$ -module and $T(X)$ as a $\mathbb{Z}[x]$ -module.

Proof First, we induct on k to show that $M_k = \langle 1, y, \dots, y^k \rangle_{\mathbb{C}[x]}$ is free of rank $k + 1$ whenever $k \leq n - 1$. The base case is immediate since $M_0 = \mathbb{C}[x]$.

Since $M_k = M_{k-1} + \langle y^k \rangle$, to see that $M_k = M_{k-1} \oplus \langle y^k \rangle$, it is enough to show that $M_{k-1} \cap \langle y^k \rangle = \{0\}$. Let f be an element of $M_{k-1} \cap \langle y^k \rangle$. Then we have $\{p_j\}_{j=0}^k \subset \mathbb{C}[x]$ such that

$$f = \sum_{j=0}^{k-1} p_j(x)y^j = p_k(x)y^k.$$

Hence,

$$-p_k(x)y^k + \sum_{j=0}^{k-1} p_j(x)y^j \in (P) \subset \mathbb{Q}[x, y].$$

But $k < n$ and P is irreducible, so each p_j must be zero.

Therefore, \mathcal{B} is a free basis for $\mathbb{C}[X]$ as a $\mathbb{C}[x]$ -module, and using the inequalities (3) and (4) we have

$$\text{Rk}_X^{\mathbb{C}}(\mu) = \text{Rk}_X^{\mathbb{Q}}(\mu) = \text{Rk}_X^{\mathbb{Z}}(\mu) = n.$$

$\mathbb{Q}[x]$ is a PID, so \mathcal{B} is a free basis for $T_{\mathbb{Q}}(X)$ as a $\mathbb{Q}[x]$ -module.

To see that \mathcal{B} is a free basis for $T(X)$ as a $\mathbb{Z}[x]$ -module, it remains only to show that this module is free. To do this, we show that $\langle 1, y, \dots, y^{k-1} \rangle_{\mathbb{Z}[x]} \cap \langle y^k \rangle_{\mathbb{Z}[x]} = \{0\}$, whenever $k \leq n - 1$. If f is in this intersection, then it is in $M_{k-1} \cap \langle y^k \rangle_{\mathbb{C}[x]}$, which we have already seen is trivial. □

Example 7.4 Let K be a trefoil knot. A calculation shows that $X(N) = X_A \cup X$, where X_A is a curve of abelian characters and X is a curve that contains an irreducible character. The polynomial P that defines X is $y - 1$. Therefore,

$$\text{Rk}_X^{\mathbb{C}}(\mu) = \text{Rk}_X^{\mathbb{Q}}(\mu) = \text{Rk}_X^{\mathbb{Z}}(\mu) = 1.$$

Proposition 7.2 reaffirms the well-known fact that X is not a norm curve.

Example 7.5 Let K be the figure-eight knot. A calculation shows that $X(N) = X_A \cup X_0$, where X_0 is a hyperbolic curve. The polynomial P that defines X_0 is

$$y^2 + (-1 - x^2)y + (-1 + 2x^2).$$

Therefore

$$\text{Rk}_{X_0}^{\mathbb{C}}(\mu) = \text{Rk}_{X_0}^{\mathbb{Q}}(\mu) = \text{Rk}_{X_0}^{\mathbb{Z}}(\mu) = 2.$$

$H^1(N; \mathbb{Z}_2) \cong \mathbb{Z}_2$ with generator σ . $H^1(N; \mathbb{Z}_2)$ acts on X_0 by $\sigma(x, y) = (-x, y)$. It follows that $T(Y_0)$ can be identified with the subring (with 1) of $T(X_0)$ generated by x^2 and y . Moreover, Y_0 can be identified with the zeros of $y^2 + (-1 - \xi)y + (-1 + 2\xi)$, where $\xi = x^2$. We have

$$\text{Rk}_{Y_0}^{\mathbb{C}}(\mu) = \text{Rk}_{Y_0}^{\mathbb{Q}}(\mu) = \text{Rk}_{Y_0}^{\mathbb{Z}}(\mu) = 2.$$

Let $\lambda = [\beta, \mu^{-1}][\mu, \beta^{-1}]$. Then λ commutes with μ and represents the boundary slope determined by a Seifert surface. Since $\sigma(\lambda)$ is the identity, $l = I_\lambda \in T(Y_0)$. If we take (l, ξ, y) as coordinates on Y_0 , then the ideal determined by Y_0 is generated by the following polynomials in $\mathbb{C}[l, \xi, y]$:

$$\begin{aligned} p_1 &= (-1 - 4l) + (-11 + 4l)y + (16 - l)y^2 - 7y^3 + y^4, \\ p_2 &= 2 - l - 5\xi + \xi^2, \\ p_3 &= 1 - 2\xi + y + \xi y - y^2, \\ p_4 &= (2l) + \xi + (5 - l)y + 5y^2 + y^3. \end{aligned}$$

Let $M = \langle 1, y, y^2, y^3 \rangle_{\mathbb{C}[l]}$. The first polynomial describes the image of Y_0 under the map $\chi \mapsto (L(\chi), y(\chi))$. Hence, p_1 is irreducible and M is free of rank 4. The last polynomial shows that $\xi^i y^j \in M$ for every $i, j \in \mathbb{Z}^+$. It follows that

$$\text{Rk}_{Y_0}^{\mathbb{C}}(\lambda) = \text{Rk}_{Y_0}^{\mathbb{Q}}(\lambda) = \text{Rk}_{Y_0}^{\mathbb{Z}}(\lambda) = 4.$$

Let $s = I_{\mu^2\lambda}$. Then $s \in T(Y_0)$. Similar calculations show that $\{1, y, y^2, y^3, \xi\}$ generates $\mathbb{C}[Y_0]$ as a $\mathbb{C}[s]$ -module and that

$$\text{Rk}_{Y_0}^{\mathbb{C}}(\mu^2\lambda) = \text{Rk}_{Y_0}^{\mathbb{Q}}(\mu^2\lambda) = \text{Rk}_{Y_0}^{\mathbb{Z}}(\mu^2\lambda) = 5.$$

7.4 Other examples

Example 7.6 Let N be the Snappea census manifold M_{003} from [4]. N is a finite volume hyperbolic 3–manifold with a single cusp. $\langle \gamma, \eta \mid \gamma\eta\gamma^{-2}\eta\gamma\eta^3 \rangle$ is a presentation for $\Gamma = \pi_1 N$. The elements $\mu = (\eta^2\gamma\eta\gamma)^{-1}$ and $\lambda = (\gamma\eta\gamma)^{-1}\eta\gamma\eta$ together generate a peripheral subgroup. Define

$$m = I_\mu, \quad x = I_\gamma, \quad y = I_\eta, \quad z = I_{\gamma\eta}.$$

Let $X_0 \subset X(N)$ be a hyperbolic curve and let Y_0 be the image of X_0 in the $\text{PSL}_2\mathbb{C}$ –character variety. We can take (m, x, y, z) as coordinates on X_0 . The ideal in $\mathbb{C}[m, x, y, z]$ determined by X_0 is generated by the following three polynomials:

$$\begin{aligned} p_1 &= z^4 - mz^2 - z^2 + 1, \\ p_2 &= -z^2 + m + y, \\ p_3 &= -z^3 + mz + z + x. \end{aligned}$$

The first polynomial is irreducible and gives that $\langle 1, z, z^2, z^3 \rangle_{\mathbb{C}[m]}$ is free of rank 4. The last two polynomials show that $x, y \in \langle 1, z, z^2, z^3 \rangle_{\mathbb{C}[m]}$. It follows that $\mathbb{C}[X_0] = \langle 1, z, z^2, z^3 \rangle_{\mathbb{C}[m]}$ and

$$\text{Rk}_{X_0}^{\mathbb{C}}(\mu) = \text{Rk}_{X_0}^{\mathbb{Q}}(\mu) = \text{Rk}_{X_0}^{\mathbb{Z}}(\mu) = 4.$$

Let $\zeta = z^2$. It is straightforward to check that $m \in T(Y_0)$ and that (m, ζ) can be taken as coordinates on Y_0 . As such, Y_0 is the zero locus of the polynomial $\zeta^2 + (-m - 1)\zeta + 1$. It follows that

$$\text{Rk}_{Y_0}^{\mathbb{C}}(\mu) = \text{Rk}_{Y_0}^{\mathbb{Q}}(\mu) = \text{Rk}_{Y_0}^{\mathbb{Z}}(\mu) = 2.$$

We see that these ranks achieve the smallest possible value for the rank of a norm curve. In contrast to Example 7.5, $\text{Rk}_{Y_0}^{\mathbb{C}}(\mu) < \text{Rk}_{X_0}^{\mathbb{C}}(\mu)$.

Example 7.7 Let N be the exterior of the knot 8_{20} . The knot 8_{20} is hyperbolic. Let $X_0 \subset X(N)$ be a hyperbolic curve. As outlined in the introduction to this paper, Γ is generated by a pair of elements μ and γ , where μ is a meridian. Define $x = I_\mu$, $y = I_\gamma$ and $z = I_{\gamma\mu}$. The functions x, y, z give an embedding of X_0 into \mathbb{C}^3 .

Let $\mathcal{G} = \{g_j\}_1^5 \subset \mathbb{Z}[x, y, z]$, where:

$$\begin{aligned} g_1 &= 1 + 5y + 7y^2 + 2y^3 - 2y^4 - y^5 - 2x^2 - 6yx^2 - 3y^2x^2 + y^4x^2 + x^4 + yx^4 \\ g_2 &= -x - 3yx - y^2x - y^3x + x^3 + yx^3 + y^2z + y^3z \\ g_3 &= -1 - 4y - 3y^2 + y^3 + y^4 + x^2 + 2yx^2 - y^3x^2 + y^2xz \\ g_4 &= x + 3yx + 2y^2x - x^3 - yx^3 - z - 2yz - y^2z + x^2z \\ g_5 &= 2 + 6y - 2y^3 - 3x^2 - yx^2 + 2y^2x^2 + xz - 3yxz + z^2 \end{aligned}$$

\mathcal{G} is a Groebner basis for the ideal (\mathcal{G}) with respect to the pure lexicographic order on monomials in $\mathbb{C}[x, y, z]$ determined by the relationship $y < x < z$. Furthermore, (\mathcal{G}) is the kernel of the natural map $\mathbb{C}[x, y, z] \rightarrow \mathbb{C}[X_0]$.

We use the symbol \equiv to indicate congruence modulo (\mathcal{G}) in $\mathbb{C}[x, y, z]$ and we write $LM(f)$ for the leading monomial of $f \in \mathbb{C}[x, y, z]$ with respect to our chosen monomial order. For $1 \leq j \leq 5$, let $m_j = LM(g_j)$. Then $(m_j)_1^5 = (yx^4, y^3z, y^2xz, x^2z, z^2)$ and $m_j < m_{j+1}$.

Oertel’s work in [21] shows that N is a small knot manifold, so Corollary 5.5 implies that there are integral dependencies for y and z over $\mathbb{Z}[x]$ given by irreducible polynomials. The polynomial g_1 is the polynomial for y and a quick calculation produces the polynomial

$$\begin{aligned} z^5 - 2xz^4 + (-2 + 3x^2)z^3 + (12x - 9x^3 + x^5)z^2 \\ + (-18x^2 + 10x^4 - x^6)z + (6x^3 - 2x^5) \in (\mathcal{G}) \end{aligned}$$

for z . These polynomials also show that the set $\mathcal{B} = \{y^i z^j \mid 0 \leq i, j \leq 4\}$ is a generating set for $\mathbb{C}[X_0]$ as a $\mathbb{C}[x]$ -module, $T_{\mathbb{Q}}(X_0)$ as a $\mathbb{Q}[x]$ -module and $T(X_0)$ as a $\mathbb{Z}[x]$ -module. However, \mathcal{B} is too large to be a basis for any of these modules.

Theorem 7.8 *The set $\mathcal{B}' = \{1, y, y^2, y^3, z, y^2z\}$ is a free basis for $\mathbb{C}[X_0]$ as a $\mathbb{C}[x]$ -module, $T_{\mathbb{Q}}(X_0)$ as a $\mathbb{Q}[x]$ -module and $T(X_0)$ as a $\mathbb{Z}[x]$ -module. In particular,*

$$\text{Rk}_{X_0}^{\mathbb{C}}(\mu) = \text{Rk}_{X_0}^{\mathbb{Q}}(\mu) = \text{Rk}_{X_0}^{\mathbb{Z}}(\mu) = 6.$$

The proof of Theorem 7.8 follows from the following lemmas.

Lemma 7.9 *If $0 \leq k \leq 4$, then the rank of $\langle 1, y, \dots, y^k \rangle_{\mathbb{C}[x]}$ is $k + 1$.*

Proof The proof uses the same argument as Proposition 7.3. □

Lemma 7.10 If $k \geq 1$, then there is a polynomial $P \in \mathbb{C}[x, y]$ such that

$$x^{2k}z \equiv P + z(1 + 2y + y^2)^k.$$

Proof Induct on k and use the polynomial g_4 . □

Lemma 7.11 If $k \geq 3$, then there is a polynomial $P \in \mathbb{C}[x, y]$ such that

$$y^kz \equiv P \pm y^2z.$$

Proof Induct on k and use the polynomial g_2 . □

Lemma 7.12 If $k \geq 1$, then there is a polynomial $P \in \mathbb{C}[x, y]$ and $d_0, \dots, d_4 \in \mathbb{C}$ such that

$$x^kz \equiv P + d_0z + d_1yz + d_2y^2z + d_3xz + d_4xyz.$$

Proof The lemma is trivial if $k = 1$.

If k is even, a straightforward application of Lemmas 7.10 and 7.11 gives numbers d_0, d_1 and d_2 such that x^kz is equivalent to a polynomial in

$$d_0z + d_1yz + d_2y^2z + \mathbb{C}[x, y].$$

If $k \geq 3$ is odd, we apply the result in the even case to obtain $c_0, c_1, c_2 \in \mathbb{C}$, where x^kz is equivalent to a polynomial in

$$c_0xz + c_1xyz + c_2xy^2z + \mathbb{C}[x, y].$$

To finish the proof, notice that g_3 shows that xy^2z is represented by a polynomial in $\mathbb{C}[x, y]$. □

Lemma 7.13 Suppose $p \in \mathbb{C}[x, y]$, $g \in \mathbb{C}[x]$, and $d_0, \dots, d_4 \in \mathbb{C}$. Define

$$f = p + z(g + d_0 + d_1y + d_2y^2 + d_3x + d_4xy).$$

If $f \in (\mathcal{G})$, then $f = p$.

Proof The proof is by induction on $\deg(g)$.

If $\deg(g) = 0$, then $g \in \mathbb{C}$ and

$$f = p + (g + d_0)z + d_1yz + d_2y^2z + d_3xz + d_4xyz \in (\mathcal{G}).$$

Since \mathcal{G} is a Groebner basis for (\mathcal{G}) , some m_j must divide the leading term of the polynomial on the right. This forces $f = p$.

Let $k \geq 1$ and assume that the result holds for polynomials with degree less than k . Suppose that $g = \sum_0^k c_j x^j$. By Lemma 7.12, we have $q \in \mathbb{C}[x, y]$ and $r_0, \dots, r_4 \in \mathbb{C}$ such that

$$c_k x^k z \equiv q + r_0 z + r_1 yz + r_2 y^2 z + r_3 xz + r_4 xyz.$$

Therefore,

$$p + q + \left(\sum_{j=0}^{k-1} c_j x^j \right) z + (d_0 + r_0)z + (d_1 + r_1)yz + (d_2 + r_2)y^2 z + (d_3 + r_3)xz + (d_4 + r_4)xyz \in (\mathcal{G}).$$

By the inductive hypothesis, we have

$$\begin{aligned} c_2 = \dots = c_{k-1} &= 0, \\ c_0 + d_0 + r_0 &= 0, \\ c_1 + d_3 + r_3 &= 0, \\ d_1 + r_1 = d_2 + r_2 = d_4 + r_4 &= 0. \end{aligned}$$

Hence,

$$f = p - r_0 z + d_1 yz + d_2 y^2 z - r_3 xz + d_4 xyz.$$

As before, we must have $f = p$ since \mathcal{G} is a Groebner basis for (\mathcal{G}) . □

Lemma 7.14 For every $k \in \mathbb{Z}^+$,

$$\langle 1, y, \dots, y^k, z \rangle_{\mathbb{C}[x]} = \langle 1, \dots, y^k \rangle_{\mathbb{C}[x]} \oplus \langle z \rangle_{\mathbb{C}[x]}.$$

Proof Take $h \in \langle 1, y, \dots, y^k \rangle_{\mathbb{C}[x]} \cap \langle z \rangle_{\mathbb{C}[x]}$. Then there are polynomials $p \in \mathbb{C}[x, y]$ and $g \in \mathbb{C}[x]$ such that p represents h in $\mathbb{C}[X_0]$ and $p \equiv -gz$. Define $f = p + gz$ and notice that $f \in (\mathcal{G})$. By Lemma 7.13, $p \in (\mathcal{G})$ and $h = 0$. □

Lemma 7.15 $\langle B' \rangle_{\mathbb{C}[x]}$ is a free $\mathbb{C}[x]$ -module with rank 6.

Proof Lemmas 7.9 and 7.14 reduce the problem to showing that the intersection

$$(5) \quad \langle 1, \dots, y^3, z \rangle_{\mathbb{C}[x]} \cap \langle y^2 z \rangle_{\mathbb{C}[x]}$$

is trivial.

Since $g_3 \in \mathcal{G}$, we have that $\langle 1, \dots, y^3, xy^2 z \rangle_{\mathbb{C}[x]} = \langle 1, \dots, y^4 \rangle_{\mathbb{C}[x]}$. Together with Lemmas 7.9 and 7.14, this shows that $\langle 1, \dots, y^3, xy^2 z, z \rangle_{\mathbb{C}[x]}$ is free with rank six.

Now suppose that h is an element of the intersection (5). Then xh is an element of both $\langle 1, \dots, y^3, z \rangle_{\mathbb{C}[x]}$ and $\langle xy^2 z \rangle_{\mathbb{C}[x]}$. But we know that the intersection of this module is trivial. Hence, $hx = 0$ and so $h = 0$. □

Now to prove Theorem 7.8, we need only show that \mathcal{B}' spans the modules in question. This is straightforward using the polynomials \mathcal{G} .

Example 7.16 N is the once-punctured hyperbolic torus bundle from Section 5 of [11]. For more details in the calculations that follow, see [11]. We have

$$\Gamma = \langle \alpha, \beta, \tau \mid \tau\alpha\tau^{-1} = (\beta\alpha\beta)^{-1}, \tau\beta\tau^{-1} = \beta\alpha(\beta\alpha\beta)^{-3} \rangle.$$

The elements τ and $\lambda = [\alpha, \beta]$ form a basis for a peripheral subgroup of N . The functions

$$t = I_\tau, \quad u = I_{\alpha\tau}, \quad v = I_{\beta\tau}, \quad w = I_{\alpha\beta\tau}, \quad x = I_\alpha, \quad y = I_\beta, \quad z = I_{\alpha\beta}, \quad l = I_\lambda$$

give an embedding of $X(N)$ into \mathbb{C}^8 . $X(N)$ contains exactly two hyperbolic curves: we label them X_ϵ , where $\epsilon \in \{0, 1\}$. It is straightforward to verify that X_ϵ strongly detects the slopes represented by t and lt and does not detect a closed essential surface. This is done in [11]. It is also easy to use Theorem 3.4 to confirm these facts.

Theorem 7.17 *Let $\epsilon \in \{0, 1\}$.*

- (1) $\text{Rk}_{X_\epsilon}^{\mathbb{C}}(\lambda) = 8,$
- (2) $\text{Rk}_{X_\epsilon}^{\mathbb{Q}}(\lambda) = 16,$ and
- (3) $\text{Rk}_{X_\epsilon}^{\mathbb{Z}}(\lambda) = 17.$
- (4) *As a $\mathbb{Z}[l]$ -module, $T(X_\epsilon)$ is torsion free but not free.*

We prove Theorem 7.17 as a series of lemmas.

Suppose k is a field, let $R = k[x_0, \dots, x_n]$, and $\mathcal{I} \subseteq R$ and ideal. Take $<$ to be the monomial order generated by $x_i < x_j$ iff $i < j$ and let $\mathcal{G} = \{g_j\}_1^r$ be a Groebner basis for \mathcal{I} with respect to $<$. Write $m_j = LT(g_j)$. For $f \in R$, write \bar{f} to denote its image in R/\mathcal{I} .

Lemma 7.18 *Suppose that $m_j \in k[x_1, \dots, x_n]$ for every j . If $\{n_j\}_1^k$ is a collection of monomials in $k[x_1, \dots, x_n]$ such that*

- (1) *the $k[x_0]$ -submodule of R/\mathcal{I} generated by $\{\bar{n}_j\}_1^{k-1}$ is free of rank $k - 1,$*
- (2) *$n_i < n_j$ for every $i < j,$ and*
- (3) *n_k is not divisible by any $m_j,$*

then the $k[x_0]$ -submodule generated by $\{\bar{n}_j\}_1^k$ is free of rank $k.$

Proof Suppose $f \in R$ and

$$\bar{f} \in \langle \bar{n}_1, \dots, \bar{n}_{k-1} \rangle_{k[x_0]} \cap \langle \bar{n}_k \rangle_{k[x_0]}.$$

Then there is a set of polynomials $\{p_j\}_1^k \subset k[x_0]$ such that

$$\bar{f} = -p_k \bar{n}_k = \sum_{j=1}^{k-1} p_j \bar{n}_j.$$

In particular,

$$g := \sum_{j=1}^k p_j n_j \in \mathcal{I}.$$

If $p_k = 0$, then $\bar{f} = 0$ and we are done. Otherwise, let cx_0^s be its leading term. Then, by (2), $LT(g) = cx_0^s n_k$. Since $g \in \mathcal{I}$ and \mathcal{G} is a Groebner basis for \mathcal{I} , we must have that $LT(g)$ is divisible by some m_j . This contradicts (3), so we must have $p_k = 0$. \square

Let \mathcal{I} be the kernel of the natural map $\mathbb{C}[l, t, u, v, w, x, y, z] \rightarrow \mathbb{C}[X_\epsilon]$. The following polynomials are in \mathcal{I} :

$$8u + tyz - ty^3z, \quad 4v - 6ty + ty^3, \quad 4w + 2tz - ty^2z, \quad 2x - yz.$$

Remark Recall that Groebner bases can be used to solve the ideal membership problem.

This shows that the projection given by $(l, t, u, v, w, x, y, z) \mapsto (l, t, y, z)$ restricts to an isomorphism (defined over \mathbb{Q}) from $X_0 \cup X_1$ onto its image. Hence, we have natural identifications of $\mathbb{C}[X_\epsilon]$ and $\mathbb{C}[X_0 \cup X_1]$ with quotients of $\mathbb{C}[l, t, y, z]$. Define

$$\begin{aligned} g_1 &= 16 + (-4 - 2l)z^2 + z^4, \\ g_2 &= (-8 - 2l) + z^2 + 2y^2, \\ g_3 &= 2t + (-1)^\epsilon \cdot iz^2, \\ h &= -8 + (2 + l)z^2 + 2t^2, \end{aligned}$$

and $\mathcal{G} = \{g_1, g_2, g_3\}$. Let $<$ be the pure lexicographic monomial order for $\mathbb{C}[l, t, y, z]$ induced by the relationship $l < z < y < t$. It can be easily verified that \mathcal{G} is a Groebner basis for (\mathcal{G}) and (\mathcal{G}) is the kernel of the natural map $\mathbb{C}[l, t, y, z] \rightarrow \mathbb{C}[X_\epsilon]$. Similarly, $\{g_1, g_2, h\}$ is a Groebner basis for the ideal it generates and this ideal is the kernel of the natural map $\mathbb{C}[l, t, y, z] \rightarrow \mathbb{C}[X_0 \cup X_1]$.

Lemma 7.19 *The set*

$$\mathcal{B}_{\mathbb{C}} = \{1, z, z^2, z^3, y, zy, z^2y, z^3y\}$$

is a basis for $\mathbb{C}[X_{\epsilon}]$ as a $\mathbb{C}[l]$ -module.

Proof Since the natural map $\mathbb{C}[l, t, y, z]/(\mathcal{G}) \rightarrow \mathbb{C}[X_{\epsilon}]$ is an isomorphism, we need only show that $\mathcal{B}_{\mathbb{C}}$ is a $\mathbb{C}[l]$ -module basis for $\mathbb{C}[l, t, y, z]/(\mathcal{G})$.

Let $\mathcal{M} \subseteq \mathbb{C}[l, t, y, z]/(\mathcal{G})$ be the $\mathbb{C}[l]$ -submodule generated by $\mathcal{B}_{\mathbb{C}}$. Lemma 7.18 shows that \mathcal{M} is free with rank 8.

The polynomial g_3 shows that t may be expressed in terms of z . So, to finish the proof, it is enough to show that $y^j z^k \in \mathcal{M}$ for every pair of integers $j, k \geq 0$. By definition of $\mathcal{B}_{\mathbb{C}}$ and g_1 , $z^j \in \mathcal{M}$, for every integer $j \geq 0$. Using g_2 , we also have that $y^2 z^j \in \mathcal{M}$, for every integer $j \geq 0$. Now, using this fact and the definition of $\mathcal{B}_{\mathbb{C}}$, we conclude that if $f \in \mathcal{M}$, then $yf \in \mathcal{M}$. In particular, $y^j z^k \in \mathcal{M}$ for every pair of integers $j, k \geq 0$. Therefore, $\mathcal{M} = \mathbb{C}[l, y, z]/(\mathcal{G})$. □

Lemma 7.20 *The set*

$$\mathcal{B}_{\mathbb{Q}} = \mathcal{B}_{\mathbb{C}} \cup t\mathcal{B}_{\mathbb{C}}$$

is a basis for $T_{\mathbb{Q}}(X_{\epsilon})$ as a $\mathbb{Q}[l]$ -module.

Proof The natural map $\mathbb{C}[l, t, y, z] \rightarrow \mathbb{C}[X_{\epsilon}]$ restricts to a surjection $\mathbb{Q}[l, t, y, z] \rightarrow T_{\mathbb{Q}}(X_{\epsilon})$. The kernel of this map is $(\mathcal{G}) \cap \mathbb{Q}[l, t, y, z]$. We claim that $\{g_1, g_2, h\}$ is a Groebner basis for this ideal with respect to the monomial order $<$. It is immediate to verify that this is a Groebner basis for (g_1, g_2, h) , so we need only show that $(g_1, g_2, h) = (g_1, g_2, g_3) \cap \mathbb{Q}[l, t, y, z]$. The inclusion $(g_1, g_2, h) \subseteq (g_1, g_2, g_3) \cap \mathbb{Q}[l, t, y, z]$ is clear. To prove the opposite, suppose $f \in (\mathcal{G}) \cap \mathbb{Q}[l, t, y, z]$. Then $f(\chi) = 0$ for every $\chi \in X_{\epsilon}$. Observe that complex conjugation induces a bijection $X_0 \rightarrow X_1$. So $f(\bar{\chi})$ is also zero. In particular, f is zero on $X_0 \cup X_1$. Therefore $f \in (g_1, g_2, h)$.

Let $\mathcal{M} \subset T_{\mathbb{Q}}(X_{\epsilon})$ be the $\mathbb{Q}[l]$ -submodule generated by $\mathcal{B}_{\mathbb{Q}}$. Since $\{g_1, g_2, h\}$ is a Groebner basis for the kernel of the map $\mathbb{Q}[l, t, y, z] \rightarrow T_{\mathbb{Q}}(X_{\epsilon})$, Lemma 7.18 shows that \mathcal{M} is free with rank 16. The remainder of the proof follows an argument similar to the last part of the proof of Lemma 7.19. □

Let

$$\mathcal{B}_{\mathbb{Z}} = \{1, y, y^2, y^3, t, u, v, w, x, z, ty, uy, xy, xy^2, tx, ux, vy\}.$$

Lemma 7.21 $\mathcal{B}_{\mathbb{Z}} - \{vy\}$ *is a basis for $T_{\mathbb{Q}}(X_{\epsilon})$ as a $\mathbb{Q}[l]$ -module.*

Proof The following equations hold in $\mathbb{C}[X_\epsilon]$:

$$\begin{aligned} z^2 &= 2((4+l) - y^2) & z^3 &= 2((4+l)z - 2xy) \\ yz &= 2x & yz^2 &= 2((4+l)y - y^3) \\ yz^3 &= 2((8+2l)x - 2xy^2) & tz &= (l+4)w - 2uy \\ tz^2 &= 2((l+4)t - 2ux) & tz^3 &= 2((l^2+6l+4)w - 2(l+2)uy) \\ tyz &= 2tx & tyz^2 &= 2((l-2)ty + 4v) \\ tyz^3 &= 4((l+2)tx - 4u) \end{aligned}$$

So, every element of $\mathcal{B}_{\mathbb{Q}}$ can be expressed as a $\mathbb{Q}[l]$ -linear combination of the elements from $\mathcal{B}_{\mathbb{Z}} - \{vy\}$. Since the rank of this module equals $|\mathcal{B}_{\mathbb{Z}} - \{vy\}|$, this set is a basis. \square

Lemma 7.22 $\mathcal{B}_{\mathbb{Z}}$ generates $T(X_\epsilon)$ as a $\mathbb{Z}[l]$ -module.

Proof The following equations hold in $\mathbb{C}[X_\epsilon]$. It is tedious but straightforward to use them to show that $\mathcal{B}_{\mathbb{Z}}$ generates $T(X_\epsilon)$ as a $\mathbb{Z}[l]$ -module.

$$\begin{aligned} y^2z &= 2yx & x^2u &= 2u + xt & uy^2x &= (6+l)xu - (6+l)t \\ yz &= 2x & x^2 &= -y^2 + (6+l) & yxt &= (6+l)w - 2uy \\ yw &= 2u & y^4 &= (6+l)(y^2 - 2) & zy^2x &= 2(-y^3 + (6+l)y) \\ zyu &= 2xu & zxu &= (6+l)w - 2uy & zyx &= 2(-y^2 + (6+l)) \\ y^3z &= 2y^2x & zx &= (4+l)y - y^3 & vyu &= 3y^2x - 2(6+l)x \\ zu &= yt & u^2 &= (-6-l) + y^2 & vy^2x &= (6+l)(3w - yu) \\ xw &= yt & tyu &= 2xy - (6+l)z & wy^3 &= 2((4+l)u - xt) \\ zw &= 2t & y^2u &= (4+l)u - xt & x^2y &= -y^3 + (6+l)y \\ wy^2 &= 2uy & y^3z &= (6+l)(yx - z) & x^2t &= -2xu + (6+l)t \\ wyx &= 2ux & xv &= (6+l)w - 3uy & uy^3 &= (6+l)(yu - w) \\ xyu &= 3ty - 2v & uv &= 3yx - (6+l)z & uw &= -(4+l)y + y^3 \\ x^2y^2 &= 2(6+l) & tw &= 2yx - (4+l)z & wyu &= 2(y^2 - (6+l)) \\ ty^2x &= 4u + 2xt & wxu &= 2yx - (6+l)z & wyt &= 2(y^2x - (4+l)x) \\ wy^2x &= 6yt - 4v & u^2y &= (-6-l)y + y^3 & u^2x &= (-6-l)x + y^2x \\ vyx &= -lu + 3xt & 2vy &= (6+l)t - lxu & tu &= y^2x - (4+l)x \\ yxu &= 3ty - 2v & vy^2 &= (3-l)yt + lv & w^2 &= 2((-4-l) + y^2) \\ zv &= 2xt - 2u & zxt &= (l-2)yt + 4v & vw &= 2y^2x - 2(3+l)x \end{aligned}$$

$$\begin{aligned}
 t^2 &= (-4 - 6l - l^2) + (2 + l)y^2 & t^2x &= (-4 - 6l - l^2)x + (2 + l)y^2x \\
 t^2y &= (-4 - 6l - l^2)y + (2 + l)y^3 & txu &= (-12 - 8l - l^2) + (4 + l)y^2 \\
 uxt &= (-12 - 8l - l^2) + (4 + l)y^2 & vxt &= 2(l + 3)yx - (l + 6)(l + 1)z \\
 wxt &= (-4 - 6l - l^2)y + (2 + l)y^3 & vyt &= 2((l + 3)y^2 - (l + 1)(l + 6)) \\
 vxu &= (-6 - 7l - l^2)y + (3 + l)y^3 & tv &= (l + 1)y^3 - (5l + l^2)y \\
 v^2 &= (-12l - 2l^2) + (3 + 2l)y^2 & & \square
 \end{aligned}$$

Lemma 7.23 Define

$$\mathcal{M}_1 = \langle \mathcal{B}_{\mathbb{Z}} - \{t, ux, vy\} \rangle_{\mathbb{Z}[l]} \subset T(X_\epsilon) \quad \text{and} \quad \mathcal{M}_2 = \langle t, ux, vy \rangle_{\mathbb{Z}[l]} \subset T(X_\epsilon).$$

Then $T(X_\epsilon) = \mathcal{M}_1 \oplus \mathcal{M}_2$.

Proof Lemma 7.22 shows that $T(X_\epsilon) = \mathcal{M}_1 + \mathcal{M}_2$, so we need only show that $\mathcal{M}_1 \cap \mathcal{M}_2 = \{0\}$.

Suppose $f \in \mathcal{M}_1 \cap \mathcal{M}_2$ and label the elements of $\mathcal{B}_{\mathbb{Z}} - \{t, ux, vy\}$ as $\{b_j\}_1^{14}$. Then we have $\{p_j\}_1^{14} \cup \{q_j\}_1^3 \subset \mathbb{Z}[l]$ with

$$f = \sum_{j=1}^{14} p_j b_j = q_1 t + q_2 ux + q_3 vy.$$

This yields the expression

$$2q_3 vy = -2q_1 t - 2q_2 ux + 2 \sum_{j=1}^{14} p_j b_j.$$

However, $\mathcal{B}_{\mathbb{Z}} - \{vy\}$ is a $\mathbb{Q}[l]$ -basis for $T_{\mathbb{Q}}(X_\epsilon)$, so the only way to write $2vy$ as a $\mathbb{Z}[l]$ -linear combination in $\mathcal{B}_{\mathbb{Z}} - \{vy\}$ is listed in the proof of Lemma 7.22, namely

$$2vy = (6 + l)t - lux.$$

Hence $p_j = 0$ for every $1 \leq j \leq 14$. □

Lemma 7.24 \mathcal{M}_2 is not projective.

Proof Let

$$\pi: \bigoplus_1^3 \mathbb{Z}[l] \rightarrow \mathcal{M}_2$$

be the epimorphism given by $(p, q, r) \mapsto pt + qux + rvy$. Argue as in the proof of Lemma 7.23 to see that $\ker(\pi)$ is generated by $(l + 6, -l, -2)$. Let \mathcal{J} be the ideal $(2, l) \subset \mathbb{Z}[l]$ and view \mathcal{J} as a $\mathbb{Z}[l]$ -module. The map

$$\eta: \bigoplus_1^3 \mathbb{Z}[l] \rightarrow \mathcal{J}$$

given by $(p, q, r) \mapsto -2q + lr$ is also an epimorphism. We have $\ker(\pi) \subseteq \ker(\eta)$, so there is an epimorphism $\gamma: \mathcal{M}_2 \rightarrow \mathcal{J}$ with $\gamma\pi = \eta$. In particular,

$$\gamma(t) = 0, \quad \gamma(ux) = -2, \quad \gamma(vy) = l.$$

Let $\phi: \mathbb{Z}[l] \oplus \mathbb{Z}[l] \rightarrow \mathcal{J}$ be the epimorphism given by $(p, q) \mapsto 2p + lq$.

Suppose for a contradiction, that \mathcal{M}_2 is projective. Then γ lifts to an epimorphism

$$\psi: \mathcal{M}_2 \rightarrow \mathbb{Z}[l] \oplus \mathbb{Z}[l].$$

For $1 \leq j \leq 3$, we have $(p_j, q_j) \in \mathbb{Z}[l] \oplus \mathbb{Z}[l]$ with

$$\psi(t) = (p_1, q_1), \quad \psi(ux) = (p_2, q_2), \quad \psi(vy) = (p_3, q_3).$$

Then

$$\begin{aligned} 0 &= \gamma(t) = \phi(p_1, q_1) = 2p_1 + lq_1, \\ -2 &= \gamma(ux) = \phi(p_2, q_2) = 2p_2 + lq_2, \\ l &= \gamma(vy) = \phi(p_3, q_3) = 2p_3 + lq_3. \end{aligned}$$

Notice that the constant terms of p_1 and p_3 must be zero and the constant term of p_2 is -1 . Apply ψ to the equation $2vy + l ux = (6 + l)t$ to see that the equation

$$2p_3 + lp_2 = (6 + l)p_1$$

must hold in $\mathbb{Z}[l]$. For a contradiction, observe that the degree-one coefficient of the left hand side of this equation is odd and on the right hand side the coefficient is even. \square

Lemma 7.25 *The $\mathbb{Z}[l]$ -module $T(X_\epsilon)$ is torsion-free but not free and $\text{Rk}_{\mathbb{Z}[l]}^{\mathbb{Z}}(\lambda) = 17$.*

Proof $\mathbb{C}[X_\epsilon]$ is an integral domain, so $T(X_\epsilon)$ is torsion free as a $\mathbb{Z}[l]$ -module. Direct summands of free modules are projective. Therefore, by Lemmas 7.23 and 7.24, $T(X_\epsilon)$ is not a free $\mathbb{Z}[l]$ -module.

By Lemma 7.22, $\text{Rk}_{\mathbb{Z}[l]}^{\mathbb{Z}}(\lambda) \leq 17$. Suppose that $\{a_j\}_1^{16}$ generates $T(X_\epsilon)$ as a $\mathbb{Z}[l]$ -module. Then every element of $\mathcal{B}_{\mathbb{Z}}$ can be written as a $\mathbb{Z}[l]$ -linear combination of the a_j . By Lemma 7.20, $\{a_j\}_1^{16}$ is a free $\mathbb{Q}[l]$ -basis for $T_{\mathbb{Q}}(X_\epsilon)$. It follows that the

$\mathbb{Z}[l]$ -module generated by $\{a_j\}_1^{16}$ is also free. This is a contradiction because we know that $T(X_\epsilon)$ is not a free $\mathbb{Z}[l]$ -module. Therefore, $\text{Rk}_{X_\epsilon}^{\mathbb{Z}}(\lambda) = 17$. \square
